

7 TRAFFIC ORDERS (AN112-2007)

(a) DUNDEE CITY COUNCIL (VARIATION OF WAITING RESTRICTSIONS) (NO 2) ORDER 2007

Reference is made to Article X of the minute of meeting of this Committee of 11th December, 2006 wherein the Committee instructed and authorised the preparation of an Order introducing further measures to vary the provisions of numerous existing Waiting Restrictions Orders affecting Dundee.

The proposed Order was duly drafted and, during the statutory consultation period, no adverse comments were received.

The Committee is therefore requested to authorise formal publication of the Order as drafted.

(b) DUNDEE CITY COUNCIL (BROUGHTY FERRY OFF-STREET CAR PARKS) (VARIATION) ORDER 2007

Reference is made to Article V of the minute of meeting of this Committee of 8th January, 2007 wherein the Committee instructed and authorised the preparation of an Order introducing further measures to vary the provisions of numerous existing Waiting Restrictions Orders affecting Dundee.

The proposed Order was duly drafted and, during the statutory consultation period, no adverse comments were received.

(c) DUNDEE CITY COUNCIL (MEADOWSIDE AT ALBERT SQUARE, DUNDEE) (PROHIBITION OF DRIVING) ORDER 2007-03-29

Reference is made to Article VI of the minute of meeting of this Committee of 8th January, 2007 wherein the Committee instructed and authorised the preparation of an Order. As part of the environmental improvements in Albert Square and the relocation of the taxi rank to a point west of Reform Street, it is no longer necessary to allow taxis in Meadowside on the south side of Albert Square.

The proposed Order was duly drafted and, during the statutory consultation period, no adverse comments were received.

(d) DUNDEE CITY COUNCIL (LONG WYND, DUNDEE) (STOPPING UP) ORDER 2007

Reference is made to Article IX of the minute of meeting of this Committee of 13th November, 2006 to stop up lengths of roads and footways at Long Wynd, Dundee to accommodate a new office development on the site of the former printing works in Long Wynd.

The Order was duly prepared and advertised in The Evening Telegraph and Post and The Edinburgh Gazette, and the relevant statutory undertakers were consulted. No objections were received.

The Committee is therefore requested to authorise and confirm the Stopping Up Order, and authorise formal publication of the confirmation, after which the Order will become operative.

(e) DUNDEE CITY COUNCIL (SCHOOL KEEP CLEAR AREAS) ORDER 2007

Reference is made to Article IX of the minute of meeting of the Planning and Transportation Committee held on 11 December 2006 instructing and authorising the preparation of an Order to improve safety at school entrances and to take into account the rebuilding and relocation of schools as part of the PPP Project.
