

## **8 TRAFFIC ORDERS (AN193-2005)**

### **(a) DUNDEE CITY COUNCIL (KINGSWAY EAST SERVICE ROAD, DUNDEE) (PROHIBITION OF DRIVING) ORDER 2005**

Reference is made to Article XI of the minute of meeting of this Committee of 28th June, 2004 instructing and authorising the preparation of an Order to improve road safety and to avoid traffic congestion at Pitkerro Road/Kingsway by removing through vehicle traffic.

It is reported that the proposed Order was duly drafted and during the statutory consultation period no adverse comments were received. Thereafter, the Order was duly advertised and there were no objections.

The Committee is therefore requested to make the Order as advertised.

### **(b) DUNDEE CITY COUNCIL (PITKERRO ROAD SERVICE ROAD, DUNDEE) (PROHIBITION OF DRIVING) ORDER 2005**

Reference is made to Article IX of the minute of meeting of this Committee of 26th April, 2004 instructing and authorising the preparation of an Order to improve road safety and to avoid traffic congestion at Pitkerro Road/Kingsway by removing through vehicle traffic.
