This is to enable all the facilities associated with the operations of the Reservoir both as a water resource and as a recreational resource to be incorporated within the boundary of the Country Park.

6.3 Scottish Natural Heritage who are a statutory consultee with regard to Country Parks

under the Countryside Scotland Act (1967) Section 48 have been consulted on this matter and have no objection to the proposal. Scottish Water as the adjacent landowner have also been consulted on the proposal and do not have any objections.

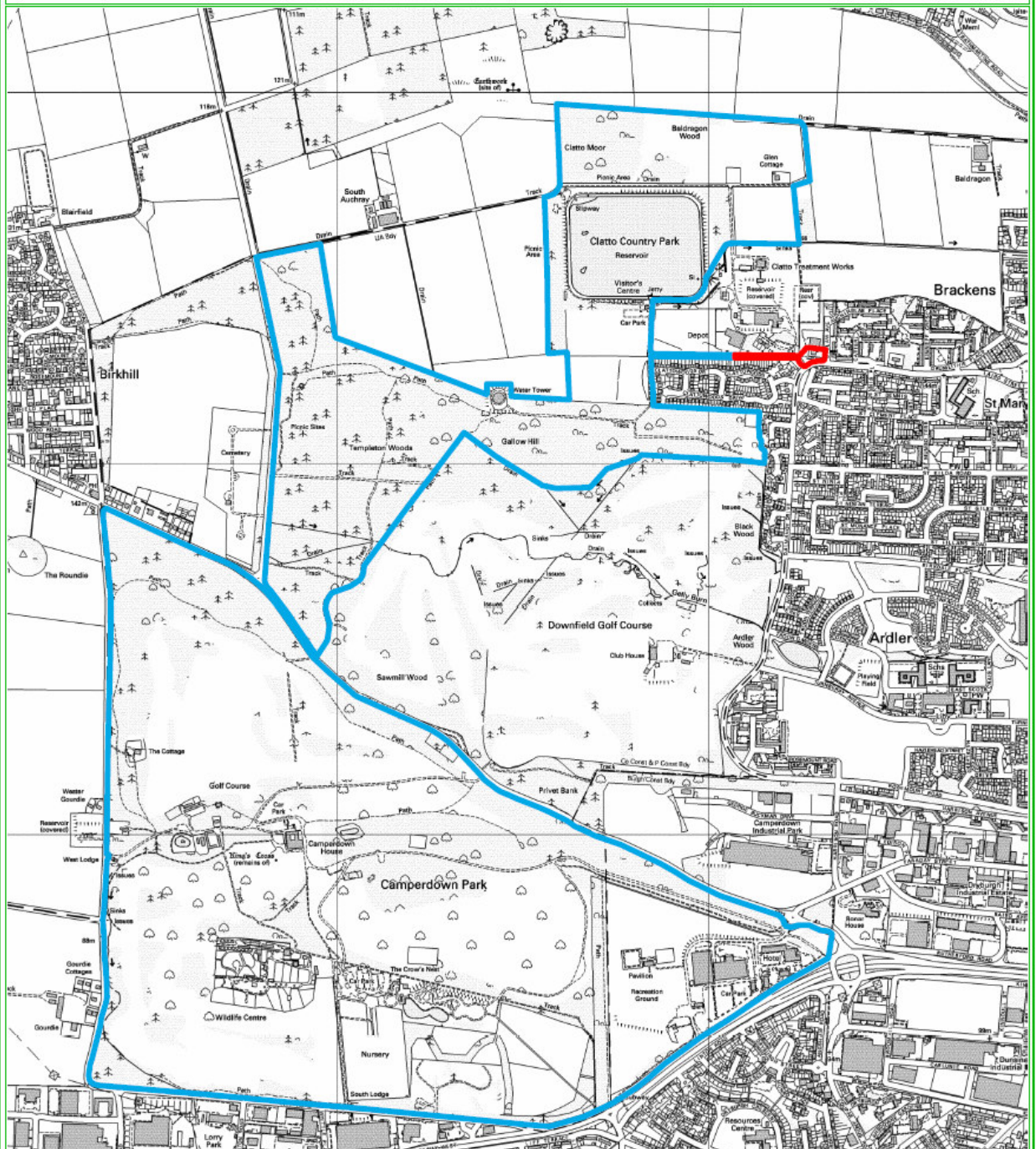
