1 PURPOSE OF REPORT

1.1 To present the recommendations and follow up arrangements for Dundee Fairness Commission and the review of the Dundee Fairness Action Plan.

2 RECOMMENDATIONS

- 2.1 It is recommended that Committee:
 - a) endorses the recommendations of the Dundee Fairness Commission 2018
 - b) approves the establishment of a further Dundee Fairness Commission (DFC) and agrees to the development of a proposal for a Fairness Leadership Panel that will bring together members, chief officers and community representatives before the end of 2019.
 - c) agrees to the appointment of two elected members to the forthcoming Dundee Fairness Commission
 - d) instructs the Chief Executive's Service to produce a revised Dundee Partnership Fairness Action Plan

3 FINANCIAL IMPLICATIONS

3.1 The next Dundee Fairness Commission will cost a total of £70,000 over three financial years March 2019 to September 2020. The Scottish Government has agreed to contribute £10,000 and the balance will be met from existing and anticipated Dundee Partnership and Community Planning Team underspends and agreed carry forwards.

4 BACKGROUND

- 4.1 <u>Dundee Fairness Commission Phase 2</u>
- 4.1.1 The second Dundee Fairness Commission was established in June 2017. It was jointly funded by the Scottish Government and the Dundee Partnership and members include a number of local people with lived experience of issues related to poverty, together with 'civic' commissioners including Councillors Alexander and Marra and Executive Directors Elaine Zwirlein and Greg Colgan.
- 4.1.2 The commission launched its final recommendations on 29 November 2018 before presenting these to the Dundee Partnership Management Group (6 December) the Cabinet Secretary for Communities and Local Government (12 December). The recommendations have been co-produced by community and civic commissioners and are included in appendix 1.

- 4.1.3 These will be incorporated into a revised Dundee Fairness Action Plan for the Council and the Dundee Partnership to sign off before the end of this financial year. This will reflect the many developments that have been presented regularly to committee through 6 monthly progress reports since the current action plan was produced in November 2016. These have largely been achieved without additional cost to the council and by accessing external funding.
- 4.1.4 The Fairness Action Plan will also include more recent commitments to respond to emerging issues such as funeral poverty, period poverty and social isolation and loneliness.
- 4.2 Dundee Fairness Commission Phase 3
- 4.2.1 The poverty truth commission model is designed to achieve a number of outcomes:
 - It gives a **meaningful voice** to people with lived experience of poverty and offers an opportunity to work with others and to facilitate personal development
 - It offers a deep and personal experience for civic leaders to gain a new perspective
 on the lives of people in Dundee struggling against the day to day reality of dealing with
 poverty, working alongside and developing relationships with community
 commissioners, and influences their professional practice
 - Taking action to address identified poverty issues/opportunities during the lifetime of the commission
 - Developing genuinely **co-produced recommendations** to create better responses to poverty in Dundee
- 4.2.2 The approach has been positively acknowledged by participants as successfully delivering all of these outcomes. It is therefore proposed that a further commission be convened to run from March 2019 to September 2020 with recruitment to begin early in 2019. The Scottish Government has offered a final contribution of £10,000 to support this on a joint basis with the balance of the required funding coming from existing and anticipated Dundee Partnership and Community Planning Team underspends and agreed carry forwards.
- 4.2.3 Two elected members have been represented on each of the Fairness Commissions held so far. It is proposed that this be repeated on the same basis as previously with a member nominated from the administration group and the majority opposition group.
- 4.3 Long Term Development Community Voice
- 4.3.1 In order to build on the experience of the current community commissioners, Faith in the Community Dundee will establish an ongoing community group that will consider fairness and poverty issues. It is anticipated that by September 2020, a further cohort of community commissioners will be ready to join this group with a view to establishing a recognised community voice on anti-poverty issues.
- 4.3.2 This group will be eligible for charitable funding and will be able to generate income to meet its own costs, thereby securing its independence and sustainability. Reflecting on their experience to date and their ambitions to continue to support and give a voice to people with lived experience of poverty in Dundee, members will be invited to participate in the forthcoming Fairness Leadership Panel (see 4.4.2 below).
- 4.4 Long Term Development Fairness Leadership Panel
- 4.4.1 While it may be desirable to run a continuing series of Fairness Commissions in Dundee, the model requires significant support and development and the cost of this is unsustainable in the long run. It is proposed, therefore, that a new, ongoing model of engagement with communities is developed to succeed the next Fairness Commission.

4.4.2 Based on a model that has been effective in Glasgow, the Fairness Leadership Panel will bring together senior Council members and officers with other partners and community leaders on poverty issues to scrutinise and report on ongoing delivery of the Dundee Fairness Action Plan. The precise format and remit of the Fairness Leadership Panel will be developed with potential members over the coming months with the aim of holding the first panel meeting before the end of 2019.
