1.0 PURPOSE OF REPORT

1.1 To seek committee approval of the Waste Management Department Service Plan Update.

2.0 RECOMMENDATIONS

2.1 It is recommended that Committee approves the Waste Management Department Service Plan Update.

3.0 FINANCIAL IMPLICATIONS

3.1 Projects and actions proposed in the Plan are provided for in the Department's Revenue Budget and Capital Plan. Where projects are contingent on the achievement of additional funding from external sources, or the continuation of existing funding, these are identified in the Plan and may be the subject of additional reports to committee.

4.0 MAIN TEXT

4.1 This report updates the Department's Service Plan 2007-2011 as approved by the committee on 10th December 2007, report number 636-2007. The aim is to update the projects under the relevant Department objectives. The opportunity has also been taken to check that the department's objectives are aligned to the Dundee Single Outcome Agreement. The Department's performance indicators are regularly scrutinised by the Best Value Performance and Efficiency Sub Committee and in the Council's annual performance report as well as by the Department's management team.

4.2 Links to the Single Outcome Agreement

The Council has approved the Single Outcome Agreement between our Dundee partners and the Scottish Government. The Department's objectives contribute to these outcomes as follows.

4.5 Projects Completed

- 4.5.1 There have been 13 projects completed since the service plan was approved, and they will now be removed from the service plan. These are listed below:
 - Work with community sector organisations to increase opportunities for the reuse of waste streams such as furniture and white goods.
 - Promote internal office furniture reuse within the council.
 - Introduce a refuse collection quality checking system and ensure all complaints are investigated thoroughly.
 - Undertake a comprehensive review of the skip/rolonof service to identify available capacity and container availability.
 - Introduce chewing gum bins into the city centre and other shopping areas on a trial basis.
 - Introduce litter as a topic during environmental talks to primary and secondary schools.
 - Approach owners of street furniture regarding graffiti and serve graffiti removal notices if required.
 - Introduce a second general Rapid Response Team and include cleaning of selected shrub beds into patrols.
 - Use enforcement powers to reduce the incidence of fly tipping and graffiti and improve street cleanliness in areas where littering occurs, taking into account language barriers where appropriate when serving notices.
 - Improve source separation of materials at Recycling Centres.
 - Achieve successful continuation of IIP accreditation.
 - Review and update existing Health and Safety Policy.
 - Develop system to monitor compliance with equality and diversity issues.

4.6 Projects behind schedule

- 4.6.1 The following projects are behind schedule and corrective action is being taken, however, where it cannot now be completed close to the original schedule a new deadline has been set as follows:
 - Train operational staff in other functional departments on LEAMS methodology and standards, new deadline December 2009.
 - Redevelop Riverside Recycling Centre (subject to Scottish Government funding) making provision for disabled access, new deadline December 2009.
 - Investigate the use of alternative fuels for example bio diesel where appropriate, new deadline December 2009.
 - Develop a council wide Litter Plan, new deadline December 2009.
 - Achieve SHAW silver award, new deadline December 2009.
 - Conduct a second EFQM assessment, new deadline October 2009.

4.7 Performance Management

4.7.1 The service plan is at the core of the department's performance management system and is systematically monitored and reviewed by the management team. All the projects and performance measures are scrutinised in a corporate system and reported to the Best Value Performance and Efficiency Sub Committee, and exception reports are produced on performance falling behind targets or project milestones. The projects included in the **Appendix 1** are all contained in the council's online planning and monitoring database for ongoing updating on progress. The Service Plan update will be added to the plans and performance page of the Council's website.

- 4.8 Risk Management
- 4.8.1 The department has updated its risk register based on this service plan update. The key risks facing the department are:
 - Closure/denial of access to disposal facility
 - Loss of key staff
 - Failure of key supplier
 - Service taken over by other agency
 - Work quantity increasing with no additional resources available
