1 PURPOSE OF REPORT

1.1 This report considers all the requests during the last year for disabled parking bays which require to be added, or removed from the Dundee City Council (Disabled Persons' Parking Places) (On-street) Order 2011.

2 RECOMMENDATION

2.1 It is recommended that the Committee approve the preparation of a Traffic Regulation Variation Order to affect the changes to the on-street disabled parking bay provision in the relevant Traffic Regulation Order for Dundee.

3 FINANCIAL IMPLICATIONS

3.1 It is proposed that the total cost of these lining and signing alterations is estimated at £22,000 and is to be met from within the Car Park Trading Account.

4 BACKGROUND

- 4.1 It is proposed to vary the undernoted Traffic Regulation Orders. The additions are due to new applicants who meet the qualifying criteria for a Blue Badge who have asked for a disabled space to aid them close to their property. The removals are due to varying circumstances where the bay is no longer required to assist a Blue Badge Holder.
