## **1 PURPOSE OF REPORT**

1.1 This report details all additional disabled parking spaces that have been approved and all the spaces that have been removed as unnecessary in the past 12 months. These amendments will require to be included in a variation to the Dundee City Council (Disabled Persons' Parking Places) (On-Street) Order 2011.

## **2 RECOMMENDATION**

2.1 It is recommended that the Committee approve the preparation of a Traffic Regulation Variation Order to affect the changes to the on-street disabled parking bay provision in the relevant Traffic Regulation Order for Dundee.

## **3 FINANCIAL IMPLICATIONS**

3.1 The total cost of removing and adding the disabled persons parking spaces is estimated at £37,000 and these costs have been met from within the Car Park Trading Account.

## **4 BACKGROUND**

4.1 The Disabled Persons' Parking (Scotland) Act 2009 places a duty on local authorities to maintain on and off street parking facilities for Disabled Persons. To ensure proper enforcement all new provision must be added to the appropriate Traffic Regulations Order otherwise the bays are deemed temporary and are only a courtesy provision.

4.2 It is proposed to vary the undernoted Traffic Regulation Orders. These additions are due to new applicants who meet the qualifying criteria for a Blue Badge who have asked for a disabled space to aid them close to their property. These removals are due to deceased disabled residents, disabled residents having moved away, or disabled bays not having a qualifying person associated with the space.
