1 PURPOSE OF REPORT

- 1.1 This report requests a decision to promote the necessary Traffic Regulation Order to allow for effective management of a new car park servicing the new Menzieshill Community Centre.
- 1.2 This report also requests a decision to vary an existing Traffic Regulation Order to include provision for Disabled parking bays for use by motorists displaying a valid Blue Badge.

2 RECOMMENDATION

- 2.1 It is recommended that the Committee:
 - a approve the preparation of a new Traffic Regulation Order which will allow the effective management of the new car park.
 - b approves the preparation of a new Traffic Regulation Order to vary the existing Dundee City Council (Disabled Persons Parking Places) (Off Street) Order 2012 to add the new Menzieshill Community Centre Car Park.

3 FINANCIAL IMPLICATIONS

3.1 The costs of preparing the Traffic Regulation Orders and necessary car park infrastructure is to be met by the Menzieshill Community Provision of the Building Strong Communities capital budget.

4 BACKGROUND

- 4.1 A request has been made to introduce a parking regime that will service the new Menzieshill Community Centre and provide sufficient time for visitors while also providing vehicular turnover.
- 4.2 It is proposed that the car park be free of charge for a period of up to 4 hours with motorists requiring to display a ticket obtainable from a nearby meter. If this period is exceeded, vehicles will be subject to a Penalty Charge Notice with a no return period of 12 hours to prevent abuse of the car park terms allowing for a single visit per day. The car park will be operational Monday to Saturday 8.00am to 6.00pm and Sunday 1.00pm to 6.00pm.
- 4.3 Vehicles displaying a valid Blue Badge will not be subject to the time period of the car park, but will not be exempt if parked within either of the two allocated electric vehicle parking bays unless they are also within an electric vehicle.
- 4.4 Existing Menzieshill Resident Permit Holders and Council staff will not be exempt from the terms of the car park Order as it is anticipated that this would heavily congest the car park and hinder it from operating as intended.
