## 1.0 PURPOSE OF THE REPORT

1.1 This report details the recommendations of the Director of Social Work on the level of payments for services provided by voluntary organisations for 2008/2009.

### 2.0 RECOMMENDATIONS

2.1 It is recommended that the Social Work Committee agrees payments to the voluntary organisations listed in Appendix 1 at the levels outlined, subject to the Director of Social Work remaining satisfied that the service provided meets the service specification.

### 3.0 FINANCIAL IMPLICATIONS

3.1 The cost of implementing the recommendations within this report is £2,446,986. This will be met from the 2008/09 Social Work revenue budget provision for payments to voluntary organisations which include funding from NHS Tayside for Resource Transfer funded projects.

## 4.0 MAIN TEXT

- 4.1 A range of voluntary organisations receive funding from the Social Work Department, as payments for services provided. The provision of these services is governed by a service level agreement with the organisation concerned.
- 4.2 The organisations listed in Appendix 1 all have service level agreements with the Social Work Department. The specification and monitoring requirements for these organisations are stringent, and as a minimum each agreement will be reassessed each year to determine the appropriate level of funding for the next year. For most organisations, an inflationary increase of 1.25% is proposed for 2008/2009.
- 4.3 A rolling programme of detailed reviews is underway. These are conducted in partnership with NHS Tayside where they contribute to the funding of the organisation. These reviews examine the content of service level agreements, the level of funding and the appropriateness of varying funding cycles, e.g. to move to 3 year budgets. Where a review results in a recommended significant change in funding, a separate report will be brought forward to the Committee.
- 4.4 Under the terms of the concordat between local authorities and the Scottish Government, many of the funding streams which were previously ring-fenced have now been included within the overall local government settlement. These changes are now reflected within the 2008/09 Social Work Revenue Budget where funds such as Mental Health Specific Grant and Changing Children's Services Fund

have been added to existing resources. Payments to voluntary organisations which were previously funded from these monies are included in Appendix 1.

4.5 The Social Work Department is currently developing an overarching commissioning strategy as outlined in the recent Social Work Inspection Report and in future years the Director of Social Work will report recommendations for payments to voluntary bodies who are contracted to provide services, within this framework.

### 5.0 POLICY IMPLICATIONS

This report has been screened for any policy implications in respect of Sustainability, Strategic Environmental Assessment, Anti-Poverty, Equality Impact Assessment and Risk Management.

There are no major issues.

### 6.0 CONSULTATION

The Chief Executive, Depute Chief Executive (Finance), Depute Chief Executive (Support Services) and Head of Finance have been consulted in the preparation of this report.
