1.0 PURPOSE OF REPORT

1.1 This report brings forward proposals for the allocation of Social Inclusion Partnership revenue funding and awards from the Small Grants Programme 2001/2002. The report also includes details of additional SIP funding resources for 2001/2002.

2.0 **RECOMMENDATIONS**

It is recommended that the Committee:

- 2.1 notes the recommendations of the Dundee Partnership Community Regeneration Group in progressing two deferred proposals; one from SIP 1 Revenue Funding for 2001/2002 as detailed in Appendix A, and one from SIP1 Capital Funding for 2001-2002.
- 2.2 agrees the award of SIP 1 and 2 Small Revenue Grants, as set out in Appendix B and C.
- 2.3 notes the additional financial resources secured towards Social Inclusion Partnership activity in 2001/2002, as detailed in Section 7 of this report.

3.0 FINANCIAL IMPLICATIONS

3.1 The allocation of SIP 1 and 2 revenue funding, as detailed in Appendix A, and Small Revenue Grants as detailed in Appendices B and C, can be contained within the Social Inclusion Partnership Fund Section of the Neighbourhood Resources and Development Department Revenue Budget 2001/2002.

4.0 LOCAL AGENDA 21 IMPLICATIONS

4.1 Priority has been given to revenue expenditure that is likely to be of benefit to the environment in the target areas. Also, meeting local needs is a central focus of the strategy for community regeneration and, as such, these measures will impact on numerous Agenda 21 targets.

5.0 EQUAL OPPORTUNITIES IMPLICATIONS

5.1 The resources made available through the Social Inclusion Partnership Fund for geographic neighbourhoods are targeted on those which fall within the most disadvantaged 10% of enumeration districts at the time of the last Census. The funding made available for the Social Inclusion Partnerships is intended to have the effect of equalling opportunities.

6.0 SOCIAL INCLUSION PARTNERSHIP 1 – ALLOCATION OF RESOURCES 2001/2002

6.1 Report 24/2001 (NRD Committee 8 January 2001) identified 4 project proposals that were deferred subject to further information and assessment. Two of the proposals have been further assessed and are recommended for funding by the Dundee Partnership Regeneration Group.

7.0 ADDITIONAL RESOURCES FOR SOCIAL INCLUSION PARTNERSHIP 1 AND 2

7.1 **FINANCIAL CONTRIBUTION FROM SCOTTISH ENTERPRISE TAYSIDE**

As part of its commitment to the Social Inclusion Partnership, Scottish Enterprise Tayside has allocated £15,000 for the calendar year 2001 towards the provision of pre-vocational and specific job related training opportunities which are not currently within existing training programmes for residents of SIP areas. Specifically, the Partnership has agreed that the funding will be allocated towards the following initiatives.

7.1.1 Individual Initiative Fund

This fund will provide costs associated with the provision of individually tailored job related training which will effectively provide access to employment. It is proposed that the Individual Initiative Fund will be administered through Dundee Employment and Aftercare Project with referrals through local staff and agencies based in the local communities; for example SET, Learning Around, Dundee College.

The Individual Initiative Fund will be administered in line with agreed eligibility criteria.

7.1.2 **Pre Employment Training**

This initiative will build on previous successful pre employment training provided in Social Inclusion Partnership 1 communities, and will provide sector based pre employment courses to better prepare residents to access jobs in specific industrial/commercial sectors (for example caring, retail and call centres).

The identification of specific training areas will be under the responsibility of the Social Inclusion Partnership Employment and Training Group which is chaired by the Economic Development Department.

The Dundee Partnership Community Regeneration Group has welcomed the financial contribution made by Scottish Enterprise Tayside and anticipates that this will impact positively on Social Inclusion Partnership communities.

7.4 EXTENSION OF SOCIAL INCLUSION PARTNERSHIP 2

The Scottish Executive has notified the Dundee Partnership that funding for the Social Inclusion Partnership 2 has been extended for an additional 4 months to 31 March 2002. This extension brings with it an additional allocation of funding for the Social Inclusion Partnership 2 programme of £143,850.

The Finance Section of Neighbourhood Resources and Development Department are currently undertaking an exercise to determine the financial implications of extending existing Social Inclusion Partnership 2 projects to 31 March 2002.

8.0 SIP 1 SMALL GRANTS FUND

8.1 Social Inclusion Partnership 1 Small Grants Fund (Appendix B)

Awards totalling £1,000 are recommended in this report.

8.2 Social Inclusion Partnership 2 Small Grants Fund (Appendix C)

Awards totalling £4,357 are recommended in this report.

9.0 CONSULTATION

- 9.1 Consultation has taken place with the Chief Executive, Director of Finance, Director of Support Services and Director of Planning and Transportation.
- 9.2 Partnership agencies associated Council Departments, community representatives and voluntary sector representatives have also been consulted and involved in the assessment of applications.
- 9.3 The recommendations are based on targets set by the Scottish Executive Development Department and Dundee Partnership. Area regeneration strategies for Kirkton, Ardler, Mid Craigie/Linlathen, and the Hilltown have also been considered prior to the recommendations brought forward in this report. These local area strategies take account of views expressed in a variety of consulting events within local communities.

10.0 BACKGROUND PAPERS

10.1 No background papers, as defined by Section 50D of the Local Government (Scotland) Act 1973 (other than any containing confidential or exempt information) were relied on to any material extent in the preparation of this report.
