BACKGROUND PAPERS	Following the fire which severely damaged Morgan Academy (Listed Building Category A) various works have been ongoing to address urgent Public Safety concerns. The final phase of this work involves the controlled demolition of dangerous internal walls. In addition to the contract costs, significant contingency items have been allowed for dealing with hazardous materials and other temporary structural measures. These contingencies reflect the unknown nature of work to be done and which are impossible to quantify at present. Discussions have been ongoing between the Council Insurers and Historic Scotland in relation to the above works.
