1. Purpose of Report

- 1.1 To report back to Committee on the consultation with regards to the Play Area Report 2000, and to gain the Committee's approval for the proposed future actions with regard to implementation of the Play Area Report 2000.
- 1.2 To gain the Committee's approval for the proposed recommendations of the Dundee Play Area Report 2000.

2. <u>Recommendations</u>

It is recommended that proposals for the future development of play areas in Dundee, as outlined in the Dundee Play Area Report 2000, be agreed, in particular:-

- (a) the urgent play areas safety issues are addressed as a priority with the approval of the first and second year's phases of implementation.
- (b) the core strategic play areas list is approved for future action, including upgrading fencing and safety surfacing, and the database of Dundee play areas is updated regularly to ensure that the information it contains is valid.

3. Financial Implications

- 3.1 With reference to the Leisure Services Committee of 20 March 2000, the total cost for the removal of 46 play areas and the retention of 80 strategic play areas, of which 56 will be refurbished under this rationalisation programme, will be £1,500,000. This sum includes £349,600 for the removal and landscaping of the play areas indicated and £1,150,400 for the refurbishment of those to remain. The overall cost of Phase 1 (2000/2001) is £150,000 and a list of the actions are attached to this report as per appendix 3.
- 3.2 The expenditure will be phased over a 6 year period commencing in 2000/2001 to ensure that the amount of work undertaken each year is manageable by existing staff. The phasing would be as follows:-

Total Financial Implication = $\pounds1,500,000$.

The current Leisure & Parks Department Capital budget includes provision for years 1-3 (2000/2001-2002/2003).

- 3.3 The cost of design consultation and supervision will be met from the existing Leisure & Parks Department Revenue budgets.
- 3.4 The overall cost of maintaining the play areas will not be increased. Any additional costs will be offset by reductions where play areas have to be removed.
- 3.5 Expenditure on Phase I will include the purchase of an inventory centred management control system for an estimated amount of £7,800. This can be met within the £150,000 Capital Budget for 2000/2001.

4. Local Agenda 21 Implications

- 4.1 The equipment that has been removed will be refurbished and re-used, where possible to improve other areas. The equipment and materials that are not re-used will be repaired for recycling. This will ensure that removal of the play areas does not create a problem of excessive disposal of materials and the environmental implications that would result.
- 4.2 All materials will be sourced from renewable resources where possible. It is proposed to install seats and litterbins made of recycled plastic. The safety surfacing used will also be of recycled materials.
- 4.3 The resulting areas, whether a play area has been removed or refurbished, will be an improvement to the environment of Dundee.

5. Equal Opportunities Implications

- 5.1 The refurbished play areas will be integrated as far as possible to ensure that people of all abilities will be able to access the facility and enjoy a fulfilling play environment along with their piers.
- 5.2 Facilities will be provided to interest children and young people of all ages.
- 5.3 All communities throughout Dundee will have access to high quality strategic play areas.
- 5.4 People living within areas affected by the Play Area Rationalisation proposals will be consulted before the details are finally decided upon.

6. Main Text

- 6.1 The Leisure Services Committee approved a remit on 16 August 1999 instructing the Director of Leisure & Parks to ensure that a survey into the condition of the Council's play areas would be reported to a Leisure Services Committee at the earliest possible time. This remit was approved unanimously by the Leisure Services Committee on that date, and subsequent an extensive audit of the play areas of Dundee was undertaken in order to fulfil the requirements of the Committee. The Leisure Services Committee of 20 March 2000 agreed the Dundee Play Area Report 2000 in principle dependent upon a 2 month consultation period with residents of all affected areas in Dundee. This consultation has now been completed and the Committee is asked to approve the revised list of play areas to be retained and refurbished, and the revised list of play areas to be removed. These are attached to the report as Appendix I and II.
- 6.2 During the consultation period, it was discovered that a play area, no. 126, Peebles Drive, had been left off the list. This has now been included on the To Be Retained List and this is the reason why the number of To Be Retained play areas has increased from 79 to 80.
- 6.3 Detailed costs for Phase One List for implementation in 2000/2001 which has already been approved by Committee will be submitted to an early Leisure Services Committee. Please see Appendix III.
- 6.4 As reported to the Leisure Services Committee of 20 March 2000, the Dundee Play Area Report 2000 takes into consideration all the health and safety implications.
 - The Leisure & Parks Department Inspection Specifications in future will conform to Part 7 of BSEN 1176:1998. This will be achieved by purchasing an inventory centred management control system.

- The Leisure & Parks Department's staff carrying out playground inspections will receive additional instruction and training to be able to conform to the rigours of this new European Standard. This will be undertaken in 2000/2001 within the Leisure & Parks Department's Training Budget
- The Leisure & Parks Department's staff will also improve the efficiency and competence of their repair cycle to comply with the regimes of Part 7 of BSEN 1176:1998 by recording maintenance visits and utilising an inventory centred management control system.
- The Leisure & Parks Department as far as is reasonably practicable, will put into place procedures to ensure that prompt action is taken to repair or make safe play equipment, if found to be defective. This will be achieved by a system of reporting and inspections using the inventory management system.
- The Leisure & Parks Department will carry out Risk Assessments on each playground under the Council's control as it is upgraded. These will then be revised for any future revisions to each play area.

Please see Appendix IV for details of proposed inventory management control system. If approved this will be reported back to a future Committee as a tender report.

- 6.6 After the play equipment has been removed and the hard standing retained or grassed over, if the area is on the Housing Department's account, it will revert to the responsibility of the Housing Department to maintain.
- 6.7 Following elected member consultation with their constituents, a decision will be required by Committee to consider the retention of the following play areas which were identified in the original report for removal.

As the playgrounds detailed above are not included in the programme of refurbishments/removal for this financial year, a decision on these can be made by Committee at a later date and considered in financial plan in later years of the implementation/removal programme.

7. Consultations

- 7.1 Consultations have been undertaken with Elected Members in regard to the implications for their wards with regard to the Play Area Report 2000
- 7.2 Consultation has also been undertaken with Housing, Education, Environmental & Consumer Protection, Social Work, and Economic Development Departments.
- 7.3 The National Playing Fields Association, Keep Our Children Safe Campaign, Play Scotland, and Handicapped Adventure Playground Association, as well as the Chief Constable of Tayside, have been asked for comments on the report. To date the National Playing Fields Association, Keep our Children Safe Campaign and Play Scotland, have responded with positive comments on its contents and offers of help in the future.
- 7.4 An accessibility analysis of those play areas proposed to be retained and upgraded in Phase I, has also been undertaken.
- 7.5 The Chief Executive, Director of Finance, and Director of Support Services have been consulted on the contents of this report.

APPENDIX IV

PROPOSED INVENTORY CENTRED MANAGEMENT SYSTEMS

- 1. The Leisure and Parks Department has an existing UNIX database system which has all the sites that Leisure and Parks carry out work on and the components that make up the site.
- 2. The object of the proposed inventory centred management system would be to utilise the existing database material and make it available for use on all the play area site.
- 3. Inventory centred management system will store and allow the update of information on individual pieces of play equipment, including maintenance and inspections as per BS EN1176. A key component of the system is its ability to make reports on various parameters.
- 4. The approximate costs for a computer based centred management system would be:-

- 5. The usage of a system would enable the establishment of an ongoing inventory inspection.
- 6. Data input will be required with a staff commitment of one person for approximately one month. This could be undertaken by Leisure and Parks Department staff.
