1 PURPOSE OF REPORT

1.1 To advise Elected Members of the outcome of the Council's participation in the National Fraud Initiative 2008-2009.

2 **RECOMMENDATIONS**

- 2.1 The Sub-Committee notes the overview of the financial outcomes contained in Appendix 1 to this report.
- 2.2 The Sub-Committee notes the Audit Scotland National Report National Fraud Initiative in Scotland Making an Impact.
- 2.3 The Council participates fully in the 2010-2011 National Fraud Initiative including the computer matching of discretionary datasets.

3 FINANCIAL IMPLICATIONS

3.1 None.

4 BACKGROUND

- 4.1 There have now been three National Fraud Initiatives in 2004/05, 2006/07 and 2008/09 and Dundee City Council has participated in all of them. Originally a small number of databases were used to detect irregularities but this has now increased significantly with around 20 databases now being used to cross-match data. As well as detecting frauds and irregularities, the National Fraud Initiative also provides participants with assurance as to the integrity and robustness of the databases being analysed.
- 4.2 At a national level Audit Scotland has recently published a report on the National Fraud Initiative in Scotland - Making an Impact which sets out the results of the 2008/09 exercise at a national level. Audit Scotland reported that the most recent exercise has been the most successful anti fraud exercise yet with results worth £21.1 million of public money. A full copy of the report is attached.

5 FINANCIAL OUTCOMES

- 5.1 Overall savings identified for Dundee City Council as a result of the National Fraud Initiative are in excess of £500,000 and as detailed in Appendix 1. This may be regarded as a very good outcome from carrying out the exercise.
- 5.2 It should be noted that some of these savings relate to earlier years as NFI cases can take some time to be completed.
- 5.3 Attention is drawn to the recent successful prosecution for fraud which featured prominently in the local press. Benefits of around £37,000 were fraudulently obtained. The fraudster was put on probation and given a tagging order.

6 **FUTURE INITIATIVES**

- 6.1 The Council is due to take part in the National Fraud Initiative 2010-2011. Guidelines for this exercise will be released over the summer. It is intended that the Council will cross-match all datasets within the scope of NFI 2010-2011 even though some of these are discretionary.
- 6.2 The main National Fraud Initiative is expected to continue every two years. It is also anticipated that more and more databases will be icluded in future exercises.

7 POLICY IMPLICATIONS

7.1 This report has been screened for any policy implications in respect of Sustainability, Strategic Environmental Assessment, Anti-Poverty, Equality Impact Assessment and Risk Management. There are no major issues.
