1.0 PURPOSE OF THE REPORT

1.1 This report recommends the level of standard charge to be applied in 2004/05 for local authority residential accommodation for adults.

2.0 RECOMMENDATIONS

2.1 It is recommended that the Social Work Committee:-agrees standard charges for local authority residential accommodation as laid out in Appendix 1.

3.0 FINANCIAL IMPLICATIONS

3.1 Adopting the recommended standard charges will have no effect on the present level of budgeted income, as no residents presently pay the full standard charge.

6.0 MAIN TEXT

- The local authority is required by statute to review its charges for residential accommodation for adults each year. The method of calculating charges is prescribed by regulation and guidance and results in a full economic cost being calculated, including overheads and the cost of capital.
- Each resident has a full assessment of their financial circumstances each year, which determines the amount they are required to contribute to the cost of their care. Only those residents with savings in excess of £19,000 or significant weekly income pay the full standard charge for their care. At present no residents pay the full standard charge. Every resident retains at least £18.10 per week in personal allowance.

7.1 The Chief Executive, Depute Chief Executive (Finance) and Depute Chief Executive (Support Services) have been consulted in the preparation of this report.
