1. **PURPOSE OF REPORT**

1.1 This report provides an update on all of the commitments set out in the Dundee Partnership's Fairness Action Plan and identifies new actions which have been introduced since the first progress report in January 2013.

2. **RECOMMENDATIONS**

2.1 It is recommended that Committee notes the progress made on the commitments in the Fairness Action Plan and approves the additional items.

3. FINANCIAL IMPLICATIONS

3.1 There are no new additional financial commitments contained in this report.

4. **BACKGROUND**

- 4.1 The Dundee Partnership adopted *For Fairness in Dundee, a strategy for challenging poverty and promoting inclusion in Dundee* at its meeting in June 2012. A detailed action plan was prepared with commitments against each of the outcomes in the framework which addressed Social Inclusion, Financial Inclusion, Communities and Neighbourhoods, Health, Employability and Learning.
- 4.2 Progress on the Fairness Plan is being monitored using the Council's Online Plan Monitoring Database and appendix one shows full details of the most recent updates provided by lead officers.
- 4.3 The challenge facing people experiencing deprivation in Dundee has been exacerbated by the escalating impact of ongoing welfare benefit reform. The Council and its partners have taken extensive and early action to mitigate the impact on citizens in Dundee with a particular emphasis on the need to support Council and other social housing tenants to manage the additional costs created by the bedroom tax. The range of workstreams set up to assist in managing the welfare reform changes was set out in Committee Report 301-2013 and these reflect close collaboration with partners, including preventative approaches and initiatives to create additional support to those requiring benefit advice and help for people to manage their benefits online.
- 4.4 Appendix one demonstrates that reasonable progress is being made against all the commitments on the Plan. In addition to those identified in the first progress report in January 2013, further significant achievements include:
 - implementation of the Scottish Welfare Fund from 1 April 2013
 - piloting of Welfare Reform Action Plans by frontline staff in Dundee House, East District Housing Office and four libraries

- adoption of the Housing Incentive Scheme and amending the Housing Allocation Policy to prioritise tenants who are under-occupied
- adoption of a Corporate Debt Policy
- securing Big Lottery Funding of £339,237 for the Support and Connect project
- providing additional financial support to the Dundee Food Bank and Discovery Credit Union
- Community Benefit clauses being pursued for all projects connected to the Waterfront regeneration and across procurement processes
- introduction of the Employer Pledge to maximise employment and training opportunities with 40 businesses signed up
- commitment to create 50 Modern Apprenticeships within the Council
- raising the level of school leavers reaching positive destinations to above the Scottish average
- allocation from the Scottish Government's Youth Employment Scotland Fund to create jobs for young people with small to medium enterprises
- removal of musical tuition fees
- introduction of new concessionary leisure services
- providing free wi-fi access in all community centres
- approval of a community asset transfer policy
- 4.5 Since the original action plan was agreed in June 2012, Council departments have continued to develop further ways of promoting fairness and reducing deprivation. These will be added to the monitoring database and progress towards these will be included in subsequent reports to Committee:
 - creation of the ASPIRE arts education project for 2,000 primary school children in community regeneration areas
 - introduction of IT Family Support Workers to primary schools in community regeneration areas
 - identification of support available to those with gambling addictions
 - address the number and provision of payday loan companies in Dundee
 - creation of holiday activity programmes for children from families experiencing deprivation
 - creation and rolling out of the Family Splash project offering affordable access to swimming pools

5. **POLICY IMPLICATIONS**

This report has been screened for any policy implications in respect of Sustainability, Strategic Environmental Assessment, Anti-Poverty, Equality and Impact Assessment and Risk Management. The Fairness Action Plan and progress in implementing it, will make a significant positive impact in tackling poverty in Dundee.
