1 PURPOSE OF REPORT

1.1 The purpose of this report is to inform the Committee of Departmental performance during they year 2004/2005.

2 **RECOMMENDATIONS**

2.1 It is recommended that the Committee notes the contents of the report.

4 LOCAL AGENDA 21 IMPLICATIONS

- 4.1 The activities covered by the plan will have significant bearing on several of the key themes of Local Agenda 21, particularly the following:-
 - Resources are used efficiently and waste minimised.
 - Local needs are met locally.
 - The opportunity to undertake satisfying work in a diverse economy.
 - Access to the skills, knowledge and information needed to enable everyone to play a full part in society.
- 4.2 Two of the sustainability achievements during the past year should be mentioned:-
 - Recycling Institute the Council formally approved its membership of the new Institute to be formed at Abertay University.
 - <u>Business Information</u> the Council is now a member of the Tayside Environmental Network and is using its services to provide environmental information to local businesses.

5 **EQUAL OPPORTUNITIES IMPLICATIONS**

- Many of the initiatives and actions outlined in the Plan are aimed at improving access to economic opportunities for all sectors of the community.
- 5.2 Two particular projects being carried out by the Department are specifically relevant to this area:-
 - Working for Families this Scottish Executive funded initiative aimed at reducing barriers for families to enable them to work is now fully operational.
 - <u>Neighbourhood Shopping Facilities</u> the Department continued its rolling programme of improving disability access at neighbourhood shopping facilities.

6 BACKGROUND

Reference is made to the Economic Development Committee meeting of 12th January 2004, wherein the Department's Service Plan for 2003/4 was approved (Report 1-2004). The first annual report on the Service Plan - i.e. for 2003/4 - was submitted to Committee on 14th June 2004 (Report 459-2004).

This report is the second annual report on the current service plan.

7 HIGH LEVEL CORE PERFORMANCE INDICATORS

7.1 The trend of general economic improvement in the City, which began in the mid 1990's, has continued during the past year and is reflected in the following high level core performance indicators.

Employment

There was a net jobs gain of 641 (or 0.8%) between 2003 and 2004. Key growth sectors were Transport, Storage & Communication; Real Estate, Renting & Business Activities and Public Administration. Sectors that experienced net losses over the period were Financial Intermediation, Manufacturing and Construction.

• <u>Unemployment</u>

The number of registered unemployed has fallen over the period from a monthly average of 4,400 in 2003 to 3,795 in 2004, i.e. a fall of 14%. Long term unemployment (i.e. 12 months plus), fell by 19% to a monthly average of 645.

Vacancies

Vacancies notified to Job Centre Plus offices in Dundee averaged 1,053 per month in 2004, a 2% increase on vacancy levels in 2003.

U/V Ratio

The U/V ratio represents the number of registered unemployed per registered vacancy and is a good indicator of economic dynamism. The City's U/V ratio improved from 4.3 in 2003 to 3.6 in 2004.

Wage Levels

The median gross weekly earnings of full time employees working in Dundee City rose from £396.7 in 2003 to £408.1 in 2004, a rise of 3%. Earnings in Scotland also rose by 3% but remained 4% lower than the earnings of Dundee City's workforce.

Company Growth

Between 2003 and 2004 the number of businesses located in Dundee fell marginally by 0.4%. However, the total number remains above the 4,000 level, which is significantly higher than any year bar 2003.

- 7.2 Although the foregoing indicators show that momentum has been maintained in Dundee's economic regeneration, the process is not yet complete and a number of significant challenges remain, such as:-
 - <u>Employment</u> the need to maintain the current momentum in the level of job creation to overcome continuing decline in the manufacturing sector.
 - <u>Unemployment Levels</u> the need to reduce levels to at least the national levels (the Dundee level continues to remain above both the Scottish and UK levels).
 - <u>Labour Supply</u> the need to increasingly target (for job creation purposes) the whole of the economically active population, not just the registered unemployed.
 - <u>U/V Ratio</u> the Council's bng-term target is to have the Dundee U/V Ratio better than the Scottish average. Although the gap has narrowed markedly, we are not quite there yet.
 - <u>Business Growth Rate</u> although improving, Dundee's rate of new business growth lags behind national rates. Dundee's long-term economic sustainability requires this deficit to be addressed.

City Centre Management

- comprehensive promotional and events programme implemented during the year
- improved safety and security measures via DUNCAN (the Dundee Coordinated Anti-Crime Network)
- improved environmental protection / customer information via City Centre Ambassadors

- strategy reviews (Economic Development Plan 2005/07; Dundee Partnership Working and Enterprise Theme Strategy 2005/10 etc)

9 MONITORING OF KEY PROJECTS

- 9.1 The Council implemented its Strategic Project Monitoring Database during the last year to monitor progress on the key projects and initiatives associated with the Council Plan 2003/2007 and the various Departmental Service Plans.
- 9.2 This system is now fully operational and projects and initiatives are being successfully monitored on-line on a regular basis. The project data-base matrix is attached as an Appendix to the report.
- 9.3 Since the system works well, it will be implemented further within the Departmental database sub-set to incorporate smaller scale projects. This will be done section-by-section on an incremental basis.

10 CONSULTATION AND REVIEW

- 10.1 An extended range of consultation procedures have taken place during the past year in conjunction with a number of major reviews which are either complete or nearing completion. These include:-
 - Economic Development Plan Review 2005/2007
 - Local Employment Action Plan Review 2005/2007
 - Business Gateway services to businesses review
- The published plans will give details of amended policies and procedures and a number of projects and initiatives will be developed during the plan periods.
- 10.3 Consultation processes have also begun in relation to a number of corporate property issues e.g. Asset Management Plan; GVA corporate property management system etc and these will continue during the coming year

11 THE YEAR AHEAD

- 11.1 A number of key projects and initiatives will be carried out during the coming year, including:-
 - Production of new Local Employment Action Plan 2005/2007
 - New formal partnership agreement with VisitScotland to run from 1st April 2006
 - Implementation of Employability Framework Initiative (an initiative launched by the Scottish Executive to reduce levels of economic inactivity and reduce the number of benefit recipients)
 - A comprehensive review of the City of Discovery Campaign and its relationship to other promotional and marketing activities
 - Undertake review of sectoral initiatives and related joint projects in parallel with expected changes in the external funding regimes (e.g. ERDF funding post 2006 and UK Regional Policy)
 - Maintain progress in the Corporate Asset Management Plan and related corporate property management processes.

- A full EFQM assessment will be carried out during the year with a new action plan developed to address required improvements.
- Participate in the review of the Business Gateway being undertaken by Scottish Enterprise

12 FINANCIAL / RESOURCE CHANGES

During the last year, the Department began the process of integrating its promotion and marketing resources (both staff and financial) within a single section - the Business Development Section. This process will continue during the year in order to achieve greater efficiency co-ordination and focus in the light of future changes to the external funding regime and trends in business development (e.g. inward investment changes).
