REPORT ON: LEASE OF WHEELED LOADER

1. PURPOSE

- 1.1 To authorise leasing arrangements for one waste handling wheeled loader for use at the Baldovie Transfer Station and Waste Processing plant.

2. RECOMMENDATIONS

- 2.1 It is recommended that the committee accept the offer (No. 1) from Scott JCB Ltd for the 436 Wastemaster at a purchase price of £71,170.

3. FINANCIAL IMPLICATIONS

- 3.1 The annual leasing cost for the machine is estimated at £11,031 for the next six years.
- 3.2 This expenditure will be met from the existing Environmental and Consumer Protection revenue budget.

4. LOCAL AGENDA 21 IMPLICATIONS

- 4.1 Resources are used efficiently and waste minimised

5. EQUAL OPPORTUNITIES

- 5.1 Under Local Government Act 1988, suppliers were required to complete and return a questionnaire to ensure that their business complies fully with the Race Relations Act 1976. All companies listed comply fully with the Act.

6. MAIN TEXT

- 6.1 The Environmental & Consumer Protection Department operate a waste transfer / processing and recycling facility at the old Baldovie Plant. This requires material to be safely loaded into machinery and vehicles.
- 6.2 The increased volumes of waste handled at the plant, requires a larger volume wheeled loader in order to maintain an efficient operation.
- 6.3 Dundee City Council went out to tender in May 2001 to seek the best and most cost effective machine type.
