6. **BACKGROUND**

- 6.1 The Council Plan 2003-2007 contained a programme of best value reviews spread over the years 2003-2007 as agreed by the sub-committee in August 2003. In March 2005, the sub-committee approved a report (174-2005) which deleted a number of reviews from the programme on the basis that these had been overtaken by events or were being addressed in other ways. This report provides up-to-date information on the reviews which have been completed since March 2005 and the reviews which are due to complete in 2006/07. As last year, the report proposes deletion of a number of reviews which were scheduled to start in 2005/06 or 2006/07.
- 6.2 The following reviews have been completed since March 2005:
 - effective approaches to creating employment opportunities
 - ways to effectively tackle the problem of fly tipping

- occupational therapy
- what responses to community safety create the best sense of improved security for older people?
- non-housing repairs
- 6.3 Appendix 1 lists the reviews which are underway and which it is expected to complete during 2006/07, along with the new reviews which will begin in 2006/07. Reports on progress with these, along with final reports containing recommendations for improvements, will be brought forward during the course of the year.
- 6.4 Appendix 2 lists those reviews which it is recommended should be deleted from the programme, along with the reasons for these recommendations.
- 6.5 Implementation of the recommendations in this report will complete the programme of best value reviews agreed in 2003. It is recommended that the Assistant Chief Executive (Community Planning) be remitted to develop proposals for the Council's approach to best value reviews in future years, as part of the process of preparing the new corporate plan to be agreed in 2007.

What measures will significantly improve educational attainment in our schools?	Two meetings of the review group have taken place and further meetings are scheduled
Is the variety of organisations that inform and advise young people leaving school delivering best value?	Third meeting of review group taking place in May, and will receive reports from two task groups established

What charges are required to the sheltered housing service to ensure it provides best value?	Review group met, but changes were brought forward as a result of discussions on the 2006/07 budget which overtook the process of the review
Are school/Council catering operations achieving health improvement objectives and should they be expanded?	Hungry for Success strategy being implemented and recent audit has commended the Council's approach
Should the Council pursue mobile/home working to reduce the overall property requirement?	Report on this subject approved by Personnel Committee in December 2005
Are changes required to services for young people who need extra support?	These issues are being taken forward through the Implementation Management Group of the new Integrated Children's Services Strategic Planning structure
How can opportunities for lifelong learning be developed?
