#### 6 BACKGROUND

- 6.1 Reference is made to the Departmental Service Plan 2004-2007, Report No 5-2004 which was approved by the Planning and Transportation Committee on 25 January 2004 in which specific key projects and performance measures and targets were set.
- 6.2 Reference is also made to the previous Annual Performance Report on the Departmental Service Plan, Report No 490-2004 which was approved by the Planning and Transportation Committee on 28 June 2004.
- 6.3 The report sets out the department's central role in the delivery of the land use, environmental and infrastructural objectives of the Community Plan and the City Vision through its ongoing commitment to the three Key Strategic Priorities set out in the Service Plan:
  - To increase the effectiveness of our contribution to the ongoing regeneration of the city's physical fabric, economy and communities;

- to increase our commitment to the proper long term management of the city's environmental and infrastructure assets;
- to increase our responsiveness to public opinion and requests for service provision;

through the progression of the programmed Key Performance Measures, Targets and Specific Objectives.

6.4 The report also sets out a summary of highlights and achievements in the year past, an evaluation of performance achieved.

### 6.5 Key Highlights and Achievements

The following are examples of key highlights and achievements in the past year:

#### - Partnership and Regeneration

In partnership the department has maximised use of available funding, particularly the Vacant and Derelict Land Fund where, for example, five sites in Stobswell have been cleared for development or environmentally improved to enhance the neighbourhood. In addition, one site in the Hilltown area has been purchased and demolished and a further site demolished and is in the Compulsory Purchase Order process.

Sites around Whitfield, Mid Craigie and Trottick have been environmentally improved to enhance marketability for development with the objective of creating more sustainable suburbs.

The Stobswell Partnership has been established.

The City Centre programme has progressed with work at Nethergate.

The Ambassador Routes Programme is nearing its conclusion with work completed at Greendykes and commenced at the West Entry, Riverside Drive.

#### – Dundee Local Plan Review

The review of the Dundee Local Plan is expected to be adopted by the Council later this year. A Public Local Inquiry into objections to the Plan was held between April and June 2004 and modifications to the Plan as a result of the Reporters' findings and other changes were reported to Committee in March 2005. This was followed by a report recommending progression to adoption of the Plan in June 2005.

The adoption of the Dundee Local Plan Review will complete the updating of the Development Plan for Dundee City, the Dundee and Angus Structure Plan having been approved by Scottish Ministers in October 2002. This clears the way for the preparation of a new Dundee City Region Plan in line with the Scottish Executive's review of the Planning System being proposed in the White Paper to be published in June 2005.

#### - Bringing Confidence into Public Transport

Ninewells Hospital Passenger Interchange, the City Centre Interchanges and the Public Transport Information Systems have all been delivered as per the programmed completion of 31 March 2005. The projects have attracted much interest from throughout the United Kingdom with many officials from Transport Authorities visiting Dundee to view the facilities. The Transport Information System was awarded the Scottish Transport Award in November 2004.

#### <u>Smartbus Project</u>

The Dundee Smartbus project is delivering major public transport improvements across the City.

Dundee was the first city to have all buses fitted with digital on-bus CCTV and a 75% reduction in vandalism has been recorded.

#### - Street Lighting Partnership

The Street Lighting Partnership has completed its first year working as a single unit operation from within Tayside Contracts Premises.

Significant success has been achieved in relation to performance and Key Performance Indicators eg 11% reduction in average cost of repair.

It has recently been agreed by Committee to extend the Partnership approach for a further 3 years.

#### – White Light Programme

The percentage of the residential areas of the city covered by the programme has risen from the previously reported figure of 38% to 46%.

#### - Central Waterfront Development

Having secured £9.3 million of Scottish Executive funding over the first 3 years and £950,000 of ERDF funding, the Dundee Central Waterfront Development project is progressing well and is on programme. The first phase of construction work started in April 2005 on the Western Road Realignment and this is due for completion in November 2005.

Further funding of £8.5 million for the subsequent 2 financial years from the Scottish Executive has been indicated.

The Dundee Central Waterfront Partnership Board and Steering Group have now been established to oversee the delivery of the overall development.

#### 6.6 **Performance Monitoring**

The processes required to formally monitor performance are now established and the department fully utilises the Council's Corporate Strategic Project Monitoring Database.

This incorporates an evaluation of progress against each of the objectives and the specific projects across the Departmental Service Plan as set out in Appendix 2 of this report.

## 6.7 New Projects

The following are examples of new significant projects which have either commenced or are due to commence in the year ahead.

• Transport Asset Management

Commence work on the development of a comprehensive transport infrastructure asset management system.

Public Safety

Evaluate the results of the City Centre Risk Assessment and develop a strategy to extend into other appropriate areas of the city.

- <u>Regeneration</u>
  - <u>Whitfield</u> Sustainable Urban Drainage Systems primary infrastructure project to provide a system for future developments to link into, rather than have several mini systems.
    - Promote new development site.
  - <u>Hilltown Park</u> Implement regeneration works to provide park as focus of new Housing development to occur in the next five years.
  - <u>Stobswell</u> Complete street and boundary works at Dura Street and continue programme into Erskine Street and North Erskine Street.
    - Secure a start to three key housing developments.
  - <u>*Pitalpin*</u> Secure an agreed masterplan with private owners/developers and get first phase underway this year.
  - <u>*City Centre*</u> Complete detailed designs for Albert Square.
- Bringing Confidence into Public Transport and Smartbus Project

Continue with the roll out of the Smartbus Project with the provision of over 300 bus shelters, all of which will have real-time information and 10% of which will have CCTV coverage at any one time.

## <u>Community Transport</u>

Delivery of a second Community Transport Vehicle which is fully accessible and implementation of the Dundee Community Transport Scheme with the provision of the technical support.

• Tay Estuary Rail Study

Continue through close working with Fife Council in developing and finalising the Tay Estuary Rail Study with the view to improving the passenger rail services and infrastructure in the Dundee "Travel to Work" area.

<u>Central Waterfront Development</u>

Strengthening works are required to the 126 year old Dock Street Railway Tunnel. These works are programmed to start on site in January 2006. Works are to be carried out in two stages between January and March 2006 and in February/March 2007.
