6.1. Furnished Accommodation

(b) Mainstream Furnished Lets

It is proposed that the weekly charge for furniture be increased as detailed to cover the increased costs in providing the service. This gives the following charges:

Fully Furnished

1-apartment	£31.94 (up 78p)
2-apartment	£36.01 (up 88p)
3-apartment	£43.59 (up £1.06)
4-apartment	£51.39 (up £1.25)

Charges for part-furnished houses are pro rata to fully furnished according to the cost of the furniture provided.

6.2. Heating Charges – Brington Place Sheltered Housing

It is proposed that the electricity charge for cooking, lighting, heating and hot water provided to the homes of tenants and warden is increased by 15p per week.

6.3. Stair Cleaning Charges

It is proposed that Stair Cleaning charges be set as follows:

6.4. Multi-Storey Launderettes

It is proposed that the charges for Multi-Storey Launderettes be increased to the following:

Auto-Wash from £1.40 to £1.45 (up 5p) Tumbler Drier from 60p to 65p (up 5p) Cabinet Drier from 60p to 65p (up 5p)

6.5. Status Enquiry Fees

The fee charged to Banks, Building Societies, etc. for status enquiries will be increased to £27.50.
