#### 1 PURPOSE OF REPORT

1.1 To seek approval for the expenditure of the additional revenue funding of £246,487 allocated to Dundee City Council to address local road priorities.

#### 2 **RECOMMENDATIONS**

2.1 It is recommended that committee approve the proposals for expenditure of the additional funding made available for dealing with the backlog in road and bridge maintenance works.

## **3 FINANCIAL IMPLICATIONS**

3.1 The works identified within this report will be met from the additional revenue grant funding of £246,487 in 2003/04.

## 4 LOCAL AGENDA 21 IMPLICATIONS

4.1 Carrying out the programme and works will ensure that the public are protected and that accessibility to facilities is maintained.

#### 5 EQUAL OPPORTUNITIES IMPLICATIONS

5.1 Implementation of these works will contribute to the Council's Local Transport Strategy by maintaining accessibility for all modes of transport throughout the City.

#### 6 BACKGROUND

- 6.1 An additional £246,487 revenue funding for 2003/04 was allocated from the Scottish Executive to deal with the backlog of road and bridge maintenance works.
- 6.2 It is proposed that this additional funding be utilised to deal with clearing part of the backlog of road and bridge maintenance works. Having reviewed the priorities for action, it is proposed to allocate the funding against three main areas:
  - Footway repairs and reconstruction;
  - Lilybank / Roberstson Street footway slippage; and
  - Road over rail protection measures.
- 6.3 There is a significant backlog of repairs required to adopted footways across the city which is estimated to be in the region of £3.5m. It is therefore proposed to allocate a large proportion of the available additional monies of £121,487 for clearing some of

this backlog in areas with the most pressing need. A list of priority areas to be dealt with using the additional funding is given in Appendix 1.

- 6.4 A significant slope slippage has occurred on the south side of Robertson Street near its junction with Lilybank Road resulting in significant longitudinal cracking to the footway. For safety reasons, temporary protective barriers have been erected to protect members of the public. It is likely that this slippage has been caused by a failure in the retaining wall system which will require to be repaired to prevent a collapse or partial collapse of the footway and road surface. It is recommended that the City Engineer carry out the necessary investigation and obtain tenders for carrying out these works for which allowances of £50,000 should be made.
- 6.5 Following the completion of road/rail interface risk assessments at bridge sites (Report No 511-2002 refers), six bridge sites were identified as high risk and requiring protection measures to be applied. These generally consist of the erection of vehicular safety barriers and the application of appropriate signing and road markings. Protection measures have been implemented at three sites, Stannergate Bridge, Magdalen Green Bridge and Ninewells Bridge. Works however are still required at, Dairy Bridge, Bridge Street and Tay Station Roundabout. It is recommended that the City Engineer obtain tenders for carrying out these works for which allowances of £75,000 should be made.

## 7 CONSULTATIONS

7.1 The Chief Executive, Director of Finance, Director of Support Services, Director of Corporate Planning, have been consulted and are in agreement with the contents of this report.
