**REPORT ON: PROVISION OF FINANCIAL SUPPORT TO NEW REGISTERED
CHILDMINDERS IN DUNDEE**

1.0 PURPOSE OF REPORT

1.1 This report seeks approval to continue to provide funding to registered childminders in Dundee.

2.0 RECOMMENDATIONS

2.1 It is recommended that the Education Committee note and approve the contents of this report and approve the award of £200 funding to each of the new childminders in Dundee as outlined in the Appendix to this report.

3.0 FINANCIAL IMPLICATIONS

3.1 The full cost of this proposal is £1600. Funding will come from the Education Department's Revenue budget 2008 - 2009.

4.0 MAIN TEXT

4.1 One of the key tasks outlined in "A Plan for Dundee's Children, 2005-8" is to, *"Provide services to support parents and carers in balancing their work and family responsibilities"*. Childminders provide a unique home based childcare service to families. They are valued as a key provider of childcare services to children of all ages and particularly to babies and toddlers for whom close relationships and a home setting are recognised to have particular benefits.

4.2 Childminders are now regulated by the Care Commission and are required to meet the National Care Standards. It is therefore important for childminders to supply age-appropriate toys and equipment and also to ensure that necessary safety equipment to meet registration requirements is in place in their homes. All newly registered childminders in Dundee are invited to submit applications for a £200 grant to support the purchase of essential resources. Eight newly registered childminders have applied for this funding.

4.3 It is proposed to award £200 to each of the eight local childminders who have recently become registered as child care providers with the Care Commission. A strong partnership approach has been developed between childminders and the Early Years and Childcare Team. All funding awards will be managed and monitored within the agreements signed with each childminder.

5.0 POLICY IMPLICATIONS

5.1 This report has been screened for any policy implications in respect of Sustainability, Strategic Environment Assessment, Anti-Poverty, Equality Impact Assessment and Risk Management.
