1. **PURPOSE OF REPORT**

1.1. This report seeks authority to review charges for (Homeless) Temporary Accommodation, Multi-Storey Launderettes, Stair Cleaning Charges, Heating Charges at Brington Place and Baluniefield Sheltered Housing Developments and Status Enquiry Fees, all being effective from 5th April 2010.

2. **RECOMMENDATIONS**

2.1. It is recommended that the Committee agree the charges proposed in this report.

3. FINANCIAL IMPLICATIONS

3.1. The proposed increase in charges will generate the income required to offset the increased costs associated with the facilities and services detailed in paragraph 4.

4. REVIEW OF CHARGES 2010/11

4.1. (Homeless) Temporary Accommodation

To meet current and estimated future costs of the service the following weekly charges are proposed:

Where no charge is shown no facility of the type is available at this time. If required such facilities will be provided and charged pro rata.

4.2. <u>Heating Charges – Brington Place and Baluniefield Sheltered Housing</u>

It is proposed that the electricity charge for cooking, lighting, heating and hot water provided to the homes of tenants is increased by 25p per week.

4.3. Multi-Storey Launderettes

It is proposed that the charges for Multi-Storey Launderettes be increased to the following:

Auto-Wash £1.90 (up 5p)
Tumble Drier £1.10 (up 5p)
Cabinet Drier £1.10 (up 5p)

4.4. Stair Cleaning

It is proposed that the stair cleaning charges are maintained at the existing rate.

4.5. Status Enquiry Fees

The fee charged to Banks, Building Societies, etc. for status enquiries will remain at £30.00.
