1 PURPOSE OF REPORT

1.1 This report details tenders received for the Dundee Discovery Smartcard Scheme and requests a decision on acceptance thereof.

2 RECOMMENDATIONS

2.1 The appointment of ESP Systex is approved.

3 FINANCIAL IMPLICATIONS

3.1 The cost of the consultancy appointment is £63,000 including expenses. The costs will be met from the Modernising Government Funding Smartcard budget. The Council received a grant of £953,000 from the Scottish Executive from the MGF2 for the smartcard project. The details of this budget was approved by the Policy and Resources Committee (Report No 842-2002) in December 2002.

4 LOCAL AGENDA 21 IMPLICATIONS

4.1 The consultants will assist in consultation with Partners on the smartcard project and will specifically address the sustainability of the scheme.

5 **EQUAL OPPORTUNITIES IMPLICATIONS**

5.1 The consultants will assist in planning to meet the objectives within the project of improving access to services and removing stigma in relation to concessions and benefits.

6 BACKGROUND TO TENDER AND SELECTION

- 6.1 Tenders were invited to assist the Dundee Discovery Card Steering Group develop a migration path to a sustainable partnership model to fit in with the work of the Scottish Citizen Account Smartcard Consortium. Specifically the consultants would address the cost/benefit analysis for the scheme and make technical recommendations for card and terminal architecture, security, a system for addition, removal and upgrade of smartcard applications and transaction analysis.
- 6.2 Four members of the Smartcard Steering Group constituted a selection panel. In total 19 tenders were received. Six were shortlisted for interview based on the quality of their submission.

The six shortlisted tenders were:

6.3 Each tender was judged on value for money and the extent to which their methodology matched the requirements of the project. ESP Systex were deemed to best meet the criteria.
