1. PURPOSE OF REPORT

To inform the Committee of the extension of Dundee Contract Services Trunked PBR Communication System to include its Parks Section to enable the Department to meet it's present and future communication requirements.

2. RECOMMENDATIONS

It is recommended that the current five year lease agreement with Securicor Information Systems be extended to include the Parks Section for the prices as detailed in the report.

3. FINANCIAL IMPLICATIONS

3.1 The annual expenditure of £6,895.72 plus the one off installation costs of £1,630.00 can be met from the revenue surplus generated by Dundee Contract Services in the current financial year and budgeted for annually over the remainder of the lease agreement period. In addition, savings of £1,787.00 per annum will be made with the removal of BT line rental charges and PMR licence fees. See attached appendix for expenditure and savings breakdowns.

4. LOCAL AGENDA 21 IMPLICATIONS

4.1 Redundant equipment will be stored and disposed of in accordance with current regulations and measures taken to ensure Public Safety and recycling of materials whenever possible.

6. MAIN TEXT

6.1 The Director of Dundee Contract Services has identified the need to renew and upgrade the Parks Section's mobile radio equipment to enable the Section to meet the operational and financial demands set over the short and longer term.

This is considered best achieved by extending the Trunked PBR Communication System to include the Parks Section which will not only improve communication but as the system is rolled out the Section will be better placed as with the rest of the Department to meet future demands.
