- 6.3 Requests for grant aid have now been assessed and recommendations for funding are outlined in Appendix 1. All applications were assessed against specific criteria. Priority has been given to those organisations, groups or individuals, whose applications are demonstrably:
 - consistent with the Council's Core Values as outlined in the Council Plan;
 - consistent with the Social Work Department's strategic aims, service plan and priorities as detailed in the Social Work Service Plan, the Joint Community Care Plan and the Children's Service Plan;
 - of potential benefit to priority groups;
 - democratic, publicly accountable and based on equal opportunities principles;
 - · cost effective, and
 - · capable of contributing to partnership working.
