1.0 PURPOSE OF THE REPORT

1.1 This report details the recommendations of the Director of Social Work on the grant awards to voluntary organisations for 2002/2003.

2.0 **RECOMMENDATIONS**

2.1 It is recommended that the Social Work Committee agrees payments of grants to the voluntary organisations listed in Appendix 1 at the levels outlined.

3.0 FINANCIAL IMPLICATIONS

3.1 The cost of implementing the recommendations within this report is £42,617. This cost can be met from the total 2002/2003 revenue budget provision for grant award payments to voluntary organisations.

5.0 EQUAL OPPORTUNITIES IMPLICATIONS

5.1 These grants are made to promote social welfare and are targeted at voluntary organisations which provide assistance and promote social inclusion amongst the most vulnerable members of the community.

6.0 MAIN TEXT

- 6.1 A range of voluntary organisations receive funding from the Social Work Department, as payment for specific services provided. The provision of these services is governed by a service level agreement with the organisation concerned.
- 6.2 However, the Social Work Department also frequently receives requests from voluntary organisations for grant funding to support activities which contribute in general to social welfare.

- 6.3 Limited budget provision has been made to meet this need, and applications for grant aid were invited in late 2001. Applications received have now been assessed and recommendations for funding are outlined in Appendix 1. All applications were assessed against specific criteria. Priority has been given to those organisations, groups or individuals, whose applications are demonstrably:
 - consistent with the Council's Core Values as outlined in the Council Plan;
 - consistent with the Social Work Department's strategic aims, service plan and priorities as detailed in the Social Work Service Plan, the Joint Community Care Plan and the Children's Service Plan;
 - of potential benefit to priority groups;
 - democratic, publicly accountable and based on equal opportunities principles;
 - cost effective, and
 - capable of contributing to partnership working.

7.0 CONSULTATION

7.1 The Director of Support Services and Director of Finance have been consulted in the preparation of this report.
