1.0 PURPOSE OF REPORT

1.1 This report makes recommendations for the allocation of small grants under the Social Inclusion Partnership 1 programme for the financial year 2002-2003.

4.1 The small grants recommended for approval within this report are intended to meet local needs. The proposals assist with implementation of Dundee Partnership's Community Regeneration Strategy. As such, the proposals will impact on a number of Agenda 21 targets.

5.0 EQUAL OPPORTUNITIES IMPLICATIONS

5.1 The recommendations for financial assistance are focused on those areas which fall within the most disadvantaged 10% of enumeration districts at the time of the 1991 census. The funding made available is intended to have the effect of equalling opportunities.

6.1 Consultation has taken place with the Chief Executive, the Directors of Finance and Support Services.

Partnership agencies, community representatives, and voluntary sector representatives have also been consulted and involved in the assessment of these small grants and in the formation of recommendations contained in this report.
