1. PURPOSE OF REPORT

1.1 To inform the Committee of fixed prices submitted by vehicle suppliers for new commercial vehicles required by Dundee Contract Services for the financial year 2002/2003.

3. FINANCIAL IMPLICATIONS

3.1 The expenditure of £ 170,532.00 plus an estimated £ 12,839.00 for painterwork, lettering and on-board storage requirements totalling £ 183,371.00 can be met from the revenue surplus generated by Dundee Contract Services in the current financial year or by operating lease if considered appropriate.

4. LOCAL AGENDA 21 IMPLICATIONS

4.1 The Committee is asked to note that the diesel engines fitted to the vehicles meet all relevant legislation relating to exhaust gas emissions. In addition the vehicle will be subject to regular emission testing and maintained to ensure compliance with standards set.

5. EQUAL OPPORTUNITIES IMPLICATIONS

5.1 Under Local Government Act 1988 potential suppliers were required to complete and return a questionnaire to ensure their business complies fully with the Race Relations Act 1976. All companies listed comply fully with the Act.

6. MAIN TEXT

6.1 Fixed price tenders were invited by way of newspaper advertisement to supply new commercial vehicles to Dundee Contract Services for the financial year 2002/2003. Each valid tender was subject to evaluation to determine "Best Value" which took into account tender prices, discounts, delivery dates, warranties, maintenance, reliability, operational needs and after sales service. The contracts will be awarded to the lowest price for each category of vehicle required.

The Chief Executive and Director of Finance have been consulted in the preparation of this report.
