1.1 To obtain approval to extend the scope of the works.

- 3.1 The Director of Finance has stated that provision will be made within the Criminal Justice Revenue Budget 2002/2003 (£21,000) and the Social Work Capital Estimates 2003/2004 (£135,000) for the additional cost of these works.
- 3.2 The additional capital expenditure should result in revenue savings as outlined in paragraph 6.2(c) and 6.2(d).

### 6.0 ESTIMATED ADDITIONAL EXPENDITURE

- 6.1 Reference is made to the report made to the meeting of the Social Work Committee held on 18<sup>th</sup> November, 2002 when expenditure of £445,900 was approved in respect of the above project.
- 6.2 The scope of the project has increased due to:
  - a) linking of alarm systems between refurbished ground floor and existing upper floor
  - b) increased power, lighting and IT installations
  - c) installation of gas fired heating installation in lieu of electric heating to achieve substantial reduction in revenue costs
  - d) replacement of electrically heated water installations with gas fired installation to achieve substantial reduction in revenue costs
  - e) removal of asbestos
  - removal of pigeon droppings and sealing off openings to prevent future access by pigeons
  - g) installation of insulation to reduce energy consumption

The additional expenditure required is approximately £156,000 inclusive of an allowance for professional fees.
