1.0 PURPOSE OF REPORT

1.1 To approve the purchase of two recycling vehicles by the Waste Management Department for the collection of domestic and commercial paper.

2.0 RECOMMENDATIONS

2.1 It is recommended that the committee accept the offer, amounting to £201,430 for the supply of two commercial paper recycling vehicles from Dennis Eagle Ltd.

3.0 FINANCIAL IMPLICATIONS

- 3.1 Funding for the lease of these vehicles is to be provided from the Strategic Waste Fund.
- 3.2 The price of the vehicles are as follows:

commercial paper recycling vehicles (two) - £201,430 (£100,715 each)

4.0 DUNDEE 21 IMPLICATIONS

- 4.1 Health is protected by creating a safe clean pleasant environment.

5.0 EQUAL OPPORTUNITIES IMPLICATIONS

5.1 Under Local Government Act 1988, suppliers were required to complete and return a questionnaire to ensure that their business complies fully with the Race Relations Act 1976. All companies listed comply fully with the Act.

6.0 MAIN TEXT

- 6.1 The Waste Management Department is seeking to increase its recycling rate by extending the existing domestic paper and commercial collection routes.
- 6.2 Dundee City Council went out to tender in November 2003 to seek the best and most cost effective vehicle types. Attached is a summary of the tender returns. In view of the delivery schedule and tight timetables the companies were approached in November 2004 to confirm the price was unchanged.
- 6.3 The vehicle types recommended for purchase are compatible with the existing types of vehicle in the department's fleet. These vehicles have proved very reliable and perform very well. The purchase of these vehicle types is also conducive with the

technical training gained so-far within the maintenance workshops and is compatible with the spare parts held in the workshop stores within the department.
