1.1 The purpose of this report is to update the Education Committee on the summary of results of the survey of parents/carers and staff of all Dundee City Council denominational primary and secondary schools. This survey was carried out following on the urgent decision of the Director of Education detailed in Report No 852-2002 approved in accordance with the Scheme of Delegation and entitled "Consultation on the Future of Denominational Secondary Schools in Dundee". A survey was carried out of all parents and staff with regard to the future of denominational secondary school provision in the City.

6.0 BACKGROUND

6.1 This survey was carried out following on the urgent decision of the Director of Education detailed in Report No 852-2002 approved in accordance with the Scheme of Delegation and entitled "Consultation on the Future of Denominational Secondary Schools in Dundee". A survey was carried out of all parents and staff with regard to the future of denominational secondary school provision in the City.

- 6.2 Survey forms were sent to the families of all children attending denominational schools in the city, and to the staff of all denominational schools in the city.
- **6.3** Survey forms were returned to the Education Department by Monday 2 December 2002.
- An official count was carried out by Education Department staff following procedures that are operational for School Board elections.

7.0 CURRENT SITUATION

The results of the survey were as follows:

- 7.1 124 respondents (6.8% of those replying) chose one of the two options but also took the opportunity to express feelings regarding the project via their questionnaire. Of these, 107 respondents who chose option 2 (8.9% of those who chose this option) chose to express their objection to the site at Kirkton Park, and called for further discussion and consultation over this aspect of the proposal.

- **7.2** School Boards of denominational schools were contacted by the Director of Education and asked to express a view regarding the options. Four boards responded. All chose Option 2. Two Boards expressed concern over the site. These responses are attached.
- 7.3 The result of the survey indicates support for the merger of Lawside Academy and St Saviour's High School on the site at Kirkton Park and the refurbishment of St John's High School.

8.0 PROPOSAL

8.1 It is proposed that the Education Committee forward the content of this report as evidence to a Best Value Review Working Group for their consideration.

St. Saviour's High School, Dunder New proposals from Dunder City Council Denominational Secondary Schools in Dunder

I refer to your recent letter sent to the Clerk of this Board.

After the original proposals were put forward, this board submitted (by letter dated 27th April 2002) its formal response to the suggestions contained in the PPP booklet, which had been distributed in November and December of last year.

The members of the School Board do, very realistically, recognise that matters have gone on apace since that time. At the most recent meeting of the Board, which was held on Tuesday 19th November 2002, the "new" proposals were outlined to the members. By good fortune, we were apprised, through the offices of Mrs. Pauline Ballie - one of our parent members - of the content of the letter that was to be sent from the Convenor and Vice-Convenor of Education the following day to the parents of every child at Catholic schools in this city.

That meeting of the School Board was followed by a public meeting – arranged at fairly short notice by the "Dundee Catholic Parents' Action Group"—to which the parents of children presently at St. Saviour's High School were invited. (I would record that I am not a member of that group.) Inevitably, a number of differing points of view were put forward and canvassed. These views were heard by elected members of the authority who were present at the meeting.

I have to record that there was a degree of unease about the wording of the second option in the questionnaire sent with the letter from the Education Committee's Convenor and Vice-Convenor. As drafted and as put to the parents, the impression was certainly given that the only option available was a new Catholic secondary school at the site at Kirkton Park. Dundee. 34 was felt, by a sizeable group of those present at the meeting of parents, that it was not only restrictive, but also inequitable, to limit the choice of site for the new school to the one location.



I think that I can say, with absolute accuracy, that if the second option had been drafted in the following terms: -

Lawside Academy and St. Saviour's High School should be merged and relocated in a new school on a site to be determined, and St. John's High School should be extended and refurbished.

and if that had been the option put to the St. Saviour's parents, then I am quietly confident that that proposal would have gained the whole hearted support of this school community. However, this board still believes that there will be a consensus for two Catholic Secondary Schools to become one on a site to be identified and agreed.

We think that it is likely that those parents from this school community who voted in favour of the second alternative may well have qualified their acceptance of the second proposal by stating in terms that the site for the new school is a matter which will require to be identified and consulted upon, and thereafter the parents' views be taken into account.

Thank you again for inviting us to respond, and I offer my apologies that this response is a little "hurried". Nothing ever proceeds at a sedate pace these days!

The cost of the possible merger of Lawside Academy and St Saviour's High School and relocating to a new school on a site at Kirkton Park and St John's High School being extended and refurbished would be an additional £2.17 million per year support from the Scottish Executive.

These resources are not available to the City Council at this time, and would require the City Council to make a future bid for Public Private Partnership funding or to utilise other capital resources which may be available.

This consultation exercise is for the purpose of informing the Best Value Review Group and does not constitute part of the current formal Schools PPP Project consultation procedures. However, further formal consultation may be required at a future date.
