1.0 PURPOSE OF REPORT

1.1 To seek approval for the introduction of a revised frequency for kerbside food waste collections during the financial year 2024/25.

2.0 RECOMMENDATIONS

2.1 Committee is asked to note the content of this report and approve an amendment to the collection frequency for kerbside food waste collections from weekly to two-weekly, during 2024/25.

3.0 FINANCIAL IMPLICATIONS

3.1 It is estimated that amending the frequency of food waste collections from weekly to two-weekly will generate a part year saving of £94,500 in 2024/2025, with net annual revenue savings of £126,000 yearly, thereafter from 2025/26 onwards. There would also be one-off transformation costs of up to an estimated £75,000 which would be met through the council's Change Fund. This is required to cover costs associated with the purchase of food waste caddies, as well as the revision and re-issue of collection calendars and supporting communications.

4.0 BACKGROUND

- 4.1 Following the introduction of the national Charter for Household Recycling and the accompanying Code of Practice in 2016, the roll out of the revised waste and recycling service provision was completed within Dundee in 2018. This included a separate food waste collection being introduced, alongside twin stream collections of dry recycling (paper/card & mixed plastics) and metals/plastic/cartons.
- 4.2 These changes were implemented to meet Dundee City Council's wider obligations, in terms of the Waste (Scotland) Regulations 2012.
- 4.3 Kerbside properties currently receive a weekly food waste collection across the city. Householders are issued with a kitchen caddy and a 23-litre kerbside caddy. Residents within flatted properties receive regular collections from either communal on street units or individual wheelie bins sited in storage areas/rear yards.

5.0 LEGISLATIVE/REGULATORY COMPLIANCE

5.1 Collection of food waste is a statutory requirement under the Waste (Scotland) Regulations 2012. The Code of Practice for Household Recycling as a minimum recommends providing 20 litres per week capacity to each household and this guidance currently advises that weekly collections are desirable not essential.

- There are potential organisational and operational implications of the <u>Circular Economy Bill</u> and corresponding Waste Route Map that are currently progressing through the parliamentary approval system. Reference is made to Article V of the Minute of Meeting of the Neighbourhood Services Committee of 22 August 2022 (Report No 199-2022 refers) which updated Committee on Dundee City Council's response to the consultation on this pending legislation.
- 5.3 The dates of implementation for this legislation remain unclear at this stage.

6.0 REVISIONS TO COLLECTIONS AND ASSOCIATED SAVINGS

- 6.1 Currently standard practice for local authorities who carry out a separate food waste collection in Scotland is to provide this service on a weekly basis. This report is seeking approval to change the frequency of kerbside food waste collections from weekly to two-weekly.
- 6.2 Staffing and vehicle provision are currently resource intensive for food waste collection and this recycling tonnage contributes overall to the lowest of any of the main recycling household waste streams. This is illustrated in the table below;

Household waste stream	Collection frequency	Annual tonnage (tonnes)	% of recycling rate

- 6.3 An assessment has shown that most properties have sufficient capacity within their kerbside food waste caddy to allow two-weekly collections to be implemented as they are currently underutilised. It is assumed that a greater number of caddies will be placed out for collection on a two-weekly basis, so an adjustment to route resource management will be organised to support the additional resource loading involved in the proposed change in frequency.
- 6.4 Additional arrangements will be made to provide an additional 23-litre food waste caddy to kerbside residents requiring supplementary capacity. This would be communicated to residents in advance of the service change being implemented. Residents living within flatted properties citywide, will continue to receive uplifts from their communal food waste bins at the current collection frequency.
- Through the change to kerbside food waste collections to a fortnightly uplift frequency, it is estimated there would be a reduction of 3 employees, equating to an annual revenue saving of £126,000. These staff savings would be achieved through a combination of non-filling of vacant posts and a reduction in the number of temporary staff employed.

- There would also be one-off transformation costs of up to an estimated £75,000 which would be met through the council's Change Fund. This would cover purchase of food waste caddies, revision and re-issue of collection calendars and communications.
- 6.7 It is recommended that the changes are introduced from the second quarter of financial year 2024/25.

7.0 POLICY IMPLICATIONS

7.1 This report has been subject to an Integrated Impact Assessment to identify impacts on Equality & Diversity, Fairness & Poverty, Environment and Corporate Risk. An impact, positive or negative, on one or more of these issues was identified. An appropriate senior manager has checked and agreed with this assessment.
