

## Declaration of Results

This report is the Declaration of Results script for Returning Officer.

Contest Name

Ward 5 - Maryfield

I will now declare the result of the election in the Ward 5 - Maryfield. There are 3 Councillors to be elected.

The electorate was 12,749 and the number of ballot papers received was 4,324 giving a percentage turnout of 33.9%. There were 111 rejected ballot papers. The quota of votes for a candidate to be elected was 1,054.

The number of first preference votes for each of the candidates was:
