

21 TRAFFIC ORDERS (AN169-2007)

- (a) DUNDEE CITY COUNCIL (EAST HENDERSON'S WYND AND ST DAVID'S LANE, DUNDEE) (STOPPING UP) ORDER 2007

Reference is made to Article III of the minute of meeting of this Committee of 12th February, 2007 wherein it was agreed to stop up lengths of roads and footways at East Henderson's Wynd and St David's Lane, Dundee to accommodate a new development.

The Order was duly prepared and advertised in the Evening Telegraph and Post and The Edinburgh Gazette, and the relevant statutory undertakers were consulted. No objections were received.

The Committee is therefore requested to authorise and confirm the Stopping Up Order, and authorise formal publication of the confirmation, after which the Order will become operative.

- (b) DUNDEE CITY COUNCIL (ARBROATH ROAD, DUNDEE) (VARIATION OF SPEED LIMITS) ORDER 2007
