## 1 PURPOSE OF REPORT

1.1 This report considers a request for alterations to waiting restrictions on a section of Riverside Drive at Bridgeview Station Cafe to preserve and improve local amenities including local businesses and the viewpoint location. This would create a turnover of parking to promote this viewpoint as a tourism attraction.

### 2 **RECOMMENDATION**

2.1 It is recommended that the Committee is asked to approve the preparation of a Traffic Regulation Variation Order to affect the changes to the waiting restrictions in the relevant Traffic Regulation Order for Dundee.

## 3 FINANCIAL IMPLICATIONS

3.1 It is proposed that the total cost of implementing these proposals, estimated at £500, be met from within the City Development Car Park Trading Account. An additional £150 is required in annual maintenance costs for signing and lining and this will also be met from within the City Development Department's Car Park Trading Account.

### 4.2 The Dundee City Council (Western Area, Dundee) (Waiting and Loading Restrictions) Order 2012

a <u>Riverside Drive (See Drawing 1) - West End Ward</u>

It is proposed to introduce limited waiting restrictions in the area to promote the adjacent business by turning over vehicles more frequently as it is believed that the area is being used as a park and ride car share facility.

b <u>Riverside Drive (See Drawing 1) - West End Ward</u>

It is proposed to introduce "At Any Time" restrictions with "No Loading At Any Time" restrictions due to the proposed narrowing of the existing carriageway, persistent blocking of the N77 cycle route and necessity of buses to access the playing fields.

c <u>Riverside Drive (See Drawing 1) - West End Ward</u>

It is proposed to introduce "Disabled" restrictions at the rate suggested by the Department for Transport and Disabled Motoring UK.
