1 PURPOSE OF REPORT

This report gives trustees details of the Alexander Torrance Cathro Bequest grant distribution in 2014, together with reports from the various organisations which have applied for 2015.

2 **RECOMMENDATIONS**

The Trustees are asked to approve the grants as shown in the attached report which amount to $\pounds 1,000$.

3 FINANCIAL IMPLICATIONS

It is anticipated that the income from the above bequest in 2014-15 will only be £70, however there is unallocated revenue funds of £4,211 which will support the grant applications received which give a disbursement of £1,000.

4 BACKGROUND

The Alexander Torrance Cathro Bequest was formed by the residue of an estate handed over to the former Corporation of Dundee in 1948, the free annual income therefrom to be used to give as many children as might have need an opportunity of enjoying an outing in the country or at the seaside.

Following redemption of the Treasury Stock, the Funds are now all invested with the Council's Loans Fund.
