#### 1.0 PURPOSE OF REPORT

1.1 To approve the purchase of 1 recycling vehicle for the collection of compostable material and 1 recycling vehicle for domestic kerbside collections for use within the Waste Management Department.

# 6.0 MAIN TEXT

- 6.1 The Waste Management Department is seeking to increase its recycling rate by extending the existing collection of botanical waste and introducing a domestic kerbside collection system for glass, cardboard, metals and textiles.
- 6.2 Dundee City Council went out to tender in November 2003 to seek the best and most cost effective vehicle type. Attached is a summary of the tender returns.

- 6.3 The kerbside vehicle recommended for purchase is compatible with the existing glass recycling vehicle currently in operation. This vehicle will also be fitted with an electronic retarder which will increase brake lining life, reduce braking noise and dust residues from brake linings.
- 6.4 The compost collection vehicle recommended for purchase is compatible with the existing compost collection vehicles within the department.
