# 1.0 PURPOSE OF REPORT

1.1 The purpose of this report is to establish a Project Board to ensure the delivery of the replacements for Longhaugh Primary School, St Luke's and St Matthew's Primary School, St Vincent's Primary School and Longhaugh Nursery on an North East campus site.

## 2.0 **RECOMMENDATIONS**

It is recommended that members:

- i. approve the establishment of a Project Board comprising Elected Members (Convener of Children and Families Service and Ward Councillors), a Roman Catholic Church representative, Executive Director of Children and Families Service or nominated member of staff, City Architect, Head Teachers, one Parent Council member from each of the schools, two pupils from each school, one Teacher Union Representative, Capital Projects Team and Head of Transportation; and
- ii. the Project Board be chaired by the Head of Service (Primary and Early Years).

## 4.0 BACKGROUND

- 4.1 At the meetings of the Policy and Resources and Education Committees on 22 June 2015 it was agreed that the City Council would commit to the development of a schools campus in the North East of the city to replace Longhaugh Primary School, St Luke's and St Matthew's Primary School, St Vincent's Primary School and Longhaugh Nursery.
- 4.2 Given the scope and complexity of this project, the need has arisen to establish a Project Board starting in May 2016. Project Boards have been used for all new build projects in recent years and are important in ensuring that the views of key stakeholders are represented.

## 5.0 PROPOSAL

5.1 It is proposed that a Project Board for the North East Campus be established in line with the recommendation from May 2016. The Board will be chaired by the Head of Service (Primary and Early Years).
