REPORT NO 2-2014

1.0 PURPOSE OF REPORT

1.1 To outline proposals for polling places and polling districts in terms of the Electoral Administration Act 2006.

2.0 RECOMMENDATION

2.1 It is recommended that the changes outlined in Section 5 be adopted in the time scales indicated.

3.0 FINANCIAL IMPLICATIONS

3.1 None.

4.0 MAIN TEXT

4.1 This is the third statutory review carried out in terms of the Electoral Administration Act 2006. The timetable for the review was as follows:-

1st October - Publication of Draft Proposals

31st October - Closing date for Representations to the draft Proposals

13th January - Proposals Put to Council

10th March - Publication of new Register based on final proposals approved by the City Council.

4.2 The second statutory review was carried out in December, 2011. Changes to legislation required the third review to be commenced in October, 2013. In addition a comprehensive review of polling districts and polling places is carried out prior to all elections, the most recent being in February, 2012.

4.3 As a result of this only a relatively small number of changes are proposed to polling places and these are largely due to the ongoing school rebuilding programme. The number of Polling Districts was reduced in 2011 for administrative ease and no major changes are proposed.

4.4 Members should note that electorate figures quoted are as at 1st November, 2013. The annual canvass is currently being undertaken and the final number of electors for each polling station will not be known until the publication of the new register on 10th March, 2014. The register will be published based on the changes identified as a result of this review.

4.5 Two maps will be on display at the meeting. One will show the changes effective from 2014 and the other the further changes which will take place in 2016/2017 when the new schools are built.

4.6 Appendix I to this report list wards and the default polling places for each polling district within the ward for 2014. A map of each ward showing the 2014 proposal is also attached.

4.7 The views of the Returning Officer were sought in terms of the regulations governing the review and the Returning Officer has indicated that he agrees with all the proposals contained in this report.

5.0 PROPOSALS

Ward 1 - Strathmartine

- 1.1 Both Baldragon Academy and Sidlawview Primary are to be replaced with new schools on the same sites in 2016/2017 although the main entrance to Baldragon will be on Harestane Road not Burn Street.
- 1.2 The boundary of polling district WAR will be reviewed once the new schools are open with a view to some electors voting at Strathmartine Church Hall which is an existing polling place and the remaining electors voting at Sidlawview along with those in WAS with Baldragon no longer being used as a polling place.
- 1.3 Existing schools will be available until the new schools open.

Ward 2 - Lochee

- 2.1 In polling district WAI, Dryburgh Resource Centre, Napier Drive may not be available from 2014 and in this regard it is recommended that the lounge at Thomson Park (Lochee United JFC), Napier Drive be used. A polling station audit has been carried out and the premises are suitable. **This change will take effect in 2014.**
- 2.2 In the Menzieshill area, Hillside and Gowriehill Primaries are to be merged. The new merged school will be sited on Dickson Avenue/Charleston Drive and electors in WAA who voted at Gowriehill will vote at the new school. WAA will also be extended to include electors in areas 7 and 12 on the enclosed map. **This is not due until 2016/17.**
- 2.3. Polling districts WAG and WAK will also be affected by the closure of Hillside and it is intended that the boundary between WAG and WAK will be realigned with electors in the North - Overton Gardens and Netherton Terrace (area 9) voting at Kirk Street Sheltered Lounge. **(This will take effect in 2014).** Electors in Ancrum Road, Glamis Road (part), Dunkeld Place, Dalrymple Street areas and Sutherland Crescent and Sutherland Street and areas to the south will vote at Ancrum Primary (areas 10 and 11) - which is not used at present but may be easier for electors in that area than going into Menzieshill. Electors in Elmwood Road and westward would vote at Menzieshill High (WAG and area 6). Polling District WAB would be expanded to include electors in Naughton Place, Lennox Gardens and Tarbet Place (area 8) and vote at Clyde Place Sheltered lounge. Polling place audits of Ancrum Road Primary and Menzieshill High School have been carried out and the buildings are suitable. In the case of the former, electors will enter via the accessible route and vote in room 6 and in the case of Menzieshill High School, the school will be open to pupils on election days as electors will use a different entrance to pupils. **These changes will take effect in 2016/2017.**
- 2.4 Electors in former WAH (area 5) will continue to vote at St Ninians.

Ward 3 - West End

- 3.1 In polling district WBD, Park Place School is closed. It is recommended that Dundee University Student Association (DUSA) be used. In addition it is further recommended that WBD be amended as outlined in the attached map (areas 1 and 2) to take in all University Halls at Hawkhill, Brown Street and Seabraes. It is hoped that this change together with collaborative working with the Students Association during the annual canvass will increase student registration levels which have historically been low. A polling place audit has been carried out and the premises are suitable. **This change will take effect in 2014.**
- 3.2 Balgay Hill Nursery is now open and it is recommended that a new polling district be created around the nursery comprising some electors in WBF, WBG and WAJ from Blackness Road, Abbotsford Street, Peddie Street, Rosefield Street and Glenagnes Road as all have to travel further afield at present (areas 4, 13, 14 and 15). A polling place audit has been carried out and the premises are suitable. Neither Victoria Park nor St Josephs Primary Schools would be affected by using the nursery and both could remain open to pupils on election day. **This change will take effect in 2014.**

- 3.3 In polling district WAL Harris Academy is being replaced. Polling will take place at West Park Centre until 2016 and thereafter Harris Academy will again be used. A polling place audit has been carried out and the premises are suitable.

Ward 4 - Coldside

- 4.1 Our Lady's and Rosebank are to merge on a new site on Ann Street/Alexander Street. **This is not due until 2016/17.** Electors in EWA who currently vote at Our Lady's will vote at the new school. It is also proposed that the use of Maxwelltown Information Centre be discontinued when the new school is built and that the electors in EWB who voted there also vote at the new school.
- 4.2 Polling district WBL will be split as per the attached map (areas 3 and 16) with electors in the west voting at St Mary Magdalene's Church, Constitution Road. **This will take effect from 2014.** Electors in the east will continue to vote at Rosebank Primary School and when the school closes will vote at the new school on Ann Street. In addition a new polling district will be created around Opal 1 (area 3). All residents there are students and will vote at DUSA. It is an Abertay campus but the students have a reciprocal arrangement with DUSA and will be used to going there socially. **This will take effect in 2014.**
- 4.3 Frances Wright Pre-School is to close in 2016/2017 and accordingly polling district EWD will be split at Clepington Road and electors on the south side of Clepington Road (area 17) will vote at United Free Church, Caird Avenue, with those in the north voting at North End JFC, Fairfield Street. **These changes will take place in 2014.**
- 4.4 In polling district EWE electors currently vote at Fleming Gardens Sheltered Lounge. It is intended that those electors in the northwestern part of that polling district (Area18) will be moved to polling district EWD and vote at the new polling station of North End JFC as it will be easier for them to get there. **This change will take effect in 2014.**

Ward 5 - Maryfield

- 5.1 In polling district WED, the Wellgate Centre is to undergo major refurbishment and it is recommended that these electors vote at Marryat Hall from 2014. Marryat Hall is currently a polling station for electors in WBC.

Ward 6 - North East

- 6.1 In EAD, Whitfield Community Centre is relocating to Lothian Crescent and it is recommended that these electors vote at Whitfield Community Services Complex. In EAE electors will vote at "The Crescent" instead of Ballumbie Primary. **These changes will take effect in 2014.**

Ward 7 - East End

No changes are proposed.

Ward 8 - The Ferry

No changes are proposed.

6.0 POLICY IMPLICATIONS

- 6.1 This report has been screened for any policy implications in respect of sustainability, strategic environmental assessment, anti poverty, equality impact assessment and risk management.
- 6.2 An equality impact assessment is attached. (Appendix II).

7.0 CONSULTATION

7.1 The Chief Executive, Director of Corporate Services, political parties represented on the Council, all Elected Members, and various disabled groups have been consulted.

As part of the consultation exercise access audits were carried out on all the polling places. These were published on the City Council's website www.dundee.gov.uk/supportservs/PollingPlaceReview together with comments received as part of the consultation.
