BACKGROUND TO THIS REPORT

As from April 2013, the Police and Fire Reform (Scotland) Act 2012 has required Police Scotland to produce and publish a Local Policing Plan for each local authority area. The LPP clearly sets out the policing priorities for the City of Dundee.

Performance in relation to the identified policing priorities is monitored and reviewed internally on a weekly basis. Quarterly reports are produced to allow scrutiny by the Dundee City Council Policy and Resource Committee. This report covers the period from 1st January 2014 to the 30th March 2014.

The data provided in this report is for information purposes to allow Board Members to conduct their scrutiny responsibilities. It should be noted that the timing of this meeting of the Board is in advance of the completion of the year end procedures and reconciliation processes that are undertaken every year in association with the publication of official statistics. Given this timing there may be minor amendments between the information in this report and the final 2013/14 statistics – for example due to delayed reporting or recording of crimes, road crashes or incidents. It would not therefore be accurate or appropriate to refer to, quote or use the data in this report as either end of year or official statistics

This report will make reference to crime groupings. Groups 1-4 refer to an amalgamation of four crime groups. They are Group 1, consisting of violent crime; Group 2 covering sexual offences; Group 3, the largest, covers a wide range of crimes of dishonesty; and Group 4 includes vandalism, fire-raising, and malicious mischief

LOCAL POLICING PRIORITY UPDATES

Public Protection and Safety

Keeping people safe by reducing violence is a key national and local priority.

Dundee City evidenced a reduction in overall violent crime in comparison to the five year average. This includes:

A reduction in overall violent crime of 25% with 65 fewer victims

A reduction in murder of 50% with 1 fewer victim

A reduction in attempted murder of 65.22% with 15 fewer victims

A reduction in serious assaults of 17.7% with 17 fewer victims

A reduction in robbery of 37.65% with 32 fewer victims

Whilst detection rates for common assault rose by almost 9%, the number of reported incidents increased slightly by 4%.

Keeping people safe in Dundee South LPA is primarily achieved through combating issues that relate to the night time economy and resulting alcohol fuelled disorder and violence. The broad range of work we undertake with licensed premises is key to the reduction in violence and obtaining further such reductions. We have run training for door and bar staff to ensure they are fully committed to the responsible sale of alcohol and maintenance of a safe environment within premises. Operation Frankie has seen officers assist door staff in ensuring members of the public who have consumed too much alcohol are not allowed entry to premises and those entering are searched when applicable.

The continuation of our weekly violence reduction plan has maintained the effective deployment of our resources to priority locations at the specific times when most needed. In the coming months we will continue to adapt and refine our resource deployments to best support licensed premises and continue to keep people safe by tackling violent crime.

In Dundee North LPA, around 50% of the violence is domestic in nature. Alcohol often fuels this violence but in contrast to Dundee South, most of this occurs within private premises. Tackling domestic abuse in all its guises remains a key priority of Police Scotland and through working with our partner agencies we have continued to improve the support we provide to victims and the management we undertake of the offender. Our commitment to supporting the victims of domestic abuse is evidenced by our officers visiting 97.5% domestic victims within 24 hours of the offender being released on bail.

February 2014 saw the introduction of the interim national Vulnerable Person Database. Through collaboration with our partner agencies this aims to assist in the accurate recording and sharing of information.

Increased public confidence in the Police Service's commitment and ability to investigate incidents of historic sexual abuse has been well publicised. As a result this year has seen the number of reported incidents of crimes of indecency rise to 338, compared with the 5 year average of 210. However the detection rate for reported incidents of rape has increased by 8.9%: again evidencing our continuing

focus on bringing offenders to justice.

Serious and Organised Crime

Operation Jonquil is a locally led initiative that focuses on targeting serious and organised crime groups that profit from the supply and distribution of the Class 'A' controlled drug — diamorphine (heroin). Efforts to detect and disrupt those responsible have seen a strategic shift in the last year: from almost exclusively aiming to seize drugs to broadening investigative scope and often targeting assets and legitimate business funded by illegal gains. This strategic shift has proved effective however is reflected in this years figures showing a 26.5% decrease in the number of reported incidents of drugs supply, production and cultivation. In the coming months we will continue to robustly apply the Scottish Governments Strategy for tackling serious and organised crime, aptly named, 'Letting Our Communities Flourish'.

Terrorism

As Scotland's fourth largest City, with a thriving port and airport, two internationally recognised Universities and infrastructure key to the Scotlish economy it is vitally important that Dundee City is responsive to the threat of terrorism.

We will work with our local and national partners in ensuring the U.K. Government's CONTEST strategy, for countering terrorism is implemented applicably across Dundee City.

The Queens Baton Relay and the Commonwealth games will place Dundee and Scotland on an international stage. We will work in conjunction with our partner agencies to ensure the safety of all persons attending such events within Dundee City.

Antisocial Behaviour

Antisocial behaviour encompasses a wide range of different types of disorder, all of which can have an adverse effect on communities. Working with our partner agencies is crucial in tackling antisocial behaviour and these efforts are coordinated through Multi Agency Tasking and Coordination Meetings at the Community Safety Hub.

This year has seen a decrease in reported incidents of vandalism with 415 fewer incidents being reported against the 5 year average. Effective deployment of resources to priority locations is vital in continuing this trend.

In the coming months with the onset of warmer weather, misuse of motorcycles will be robustly targeted with Operation Challenge. Operation Challenge will aim to deter and detect offenders by high visibility patrols in areas which in the past have suffered from such behaviour.

Road Safety

This year saw Dundee's roads become safer with a clear reduction evidenced in the number of people killed, seriously injured or injured. This included:

A 12.5% reduction in the number of people killed or seriously injured.

A 17.9% reduction in the number of people slightly injured

The number of children killed or seriously injured saw a dramatic decrease of 66.7% with the number of victims falling from 9 to 3 in comparison with the five year average. This drastic decrease is testimony to the success of working in collaboration with our partner agencies in providing education to children and drivers alike and working with the Road Policing Unit to maintain enforcement of driving offences.

This effort to make our roads safer has seen a sharp increase in the number of motoring offences which were recorded. These include a 284% increase in reports of speeding, a 539% increase in reports of seatbelt offences and a 495% increase in reports of mobile phone use whilst driving.

In the coming months we will continue to support national enforcement campaigns and strive to produce safer drivers through education and enforcement, which in turn leads to a safer road environment within Dundee.

Housebreaking

Within the Dundee City area, housebreaking have been reduced by 26%, however, detection rates for these offences have reduced by 8.9 percentage points when compared with the 5 year average.

The reduction in the number of housebreakings reflects the work done to target prolific offenders, including working with partner agencies, and also identifying and patrolling priority locations. Work within the communities has led to an increased awareness of security and reduced opportunities to offend

In the coming months we will strive to increase detection rates for housebreaking, building on good practice that has been identified and ensuring appropriate investigative support. Regular meetings take place between LPA and CID Commanders to analyse all housebreakings and ensure that appropriate opportunities are taken to detect them. Good practice guidelines have been circulated to all officers and these form the basis for investigative strategies for housebreaking.
