1.0 PURPOSE OF REPORT

1.1 This report presents the first annual update on the Education Department's revised Service Plan 2010-2012. The report also includes information on progress towards the Key Performance Indicators (KPIs) set out in the Service Plan.

2.0 **RECOMMENDATIONS**

- 2.1 The Education Committee is recommended to:
 - i. note the content of this report; and
 - ii. instruct the Director of Education to continue to monitor the progress and impact of the plan, and report back as required in the revised corporate service planning guidelines.

3.0 FINANCIAL IMPLICATIONS

3.1 The plan is subject to annual review and update. The cost of meeting the actions for the plan is contained within the Education Department Revenue Budget

4.0 MAIN TEXT

- 4.1 Work on the Service Plan is led by the Education Department's Management Team, and its Audit Group and Improving Pupil Attainment and Achievement (IPAA) Strategy Group. These last two groups are composed of representatives of teaching and support staff in the Department.
- 4.2 The work of the Education Department continues to focus on eight aims, grouped under the three key headings of Achievement, Ethos and Partnership. The Education Department manages the Service Plan through the IPAA structure which contains a number of standing groups each assigned certain targets from the Service Plan.
- 4.3 Review and monitoring of the Service Plan adheres closely to corporate service planning guidelines and quarterly updates are published on the corporate planning database. Schools are able to review progress of the Service Plan through the school improvement planning on-line database where improvement plans from all schools are also published and updated.

- 4.4 The plan has three main objectives, mirroring the objectives in the Council Service Plan. These are:
 - Getting it Right for Every Child
 - A Working City
 - Corporate Improvement and Change
- 4.5 The full details of progress in the Service Plan are included as Appendix 1
- 4.6 Of the 25 specific targets in the plan, 23 are on schedule. Two targets are behind schedule. With regard to the target 'Continue to develop the quality improvement strategy', this will be an early task for the new Director of Education and his team, and it is anticipated that a finalised revised quality improvement strategy will be completed by October 2011. The target 'Develop and implement a consistent tracking and monitoring system' has seen good progress made at stages S4-S6. Unfortunately there have been delays in the development of the software that will be used in SEEMIS to track all other stages, from early years through primary and into S1-S3. This software will now be ready for use in August.
- 4.7 Good progress is being made in the implementation of Curriculum for Excellence. Recent HMIe inspection evidence has drawn attention to positive aspects such as our approaches to health and wellbeing, our partnership with parents, the involvement of broader school communities, and the range of services available to support differing learning needs.
- 4.8 The Education Department has a statutory requirement to set and report on annual improvement objectives. These have now been incorporated into the Service Plan as a series of Key Performance Indicators (KPIs), and are updated annually along with the plan. The complete set of indicators with progress detail is included as Appendix 2.
- 4.9 Of the 32 KPIs, 24 are recorded as showing a stable or improving yearly trend, 3 show a downward trend and 5 show no trend as there is only current year data or a baseline has yet to be established. Of particular note are:
 - occupancy levels in primary and secondary schools where the ratio of pupils to available places is between 61% and 100%;
 - attainment performance in a number of measures (paragraph 4.10 below);
 - attainment performance of looked after children;
 - percentage of schools achieving ECO schools awards;
 - percentage of schools showing added value in reading and mathematics, as measured by the Performance Indicators in primary Schools (PIPS) assessments; and
 - the oral health of P1 children.
- 4.10 With regard to attainment measures, there is good evidence of sustained improvement. The percentage of young people achieving SCQF level 3 in English and Maths at the end of S4 and also of those achieving 3+ awards at SCQF level 6 by the end of S6 are especially notable (in addition to the reported KPIs, it should be noted in passing that the best ever end of S5 performance was achieved by Dundee young people at the 2010 examination diet). There has also been an improvement in terms of narrowing the attainment gap between all S4 pupils and those S4 pupils living in the 15% most deprived areas. This is a new measure and will be an area of continued focus for the Department.

4.11 Continued focus will also be required on narrowing the gap in the number of exclusions between all children and looked after children and on the percentage of young people achieving 5+ awards at SCQF level 5 by the end of S4, although the long term trend here is holding steady.

5.0 POLICY IMPLICATIONS

5.1 This report has been screened for any implications in respect of sustainability, strategic environment assessment, anti-poverty, equality impact assessment and risk management. There are no major issues.

6.0 CONSULTATION

6.1 This report has been subject to consultation with the Chief Executive, the Depute Chief Executive (Support Services) and the Director of Finance.
