## 1 PURPOSE OF REPORT

1.1 To inform Committee of the proposed repair programme for Quality of Life adopted footways in 2004/05 and 2005/06 to be funded through the Quality of Life Fund and to seek authority to commence the proposed repair programme.

#### 2 **RECOMMENDATIONS**

- 2.1 The Committee is asked to:
  - a Note the contents of this report; and agree the prioritisation of footway repairs in accordance with Appendices 1 and 2.
  - b Authorise the City Engineer to issue orders for carrying out this work based on the Unit Rate Contract for minor roadworks.
  - c Authorise the City Engineer to promote schemes based on priority ratings in the event of unforeseen slippage to the programme.

### **3** FINANCIAL IMPLICATIONS

3.1 The Depute Chief Executive (Finance) has confirmed that funding for the above works can be met from the Quality of Life Fund allowances of £200,000 in 2004/05 and £300,000 in 2005/06.

### 4 LOCAL AGENDA 21 IMPLICATIONS

4.1 Sustainable working practices and, where appropriate, recycled materials will be used in the works.

# 5 EQUAL OPPORTUNITIES IMPLICATIONS

5.1 The improved condition of footways will benefit the elderly and mobility impaired.

### 6 BACKGROUND

- 6.1 Due to ongoing obligatory commitments to safety related cyclic road maintenance activities (road markings, gulley emptying, patching etc), only a limited proportion of the road maintenance revenue budget can be targeted at reconstruction/resurfacing of both carriageways and footways, with the latter currently being allocated some £230,000 from the overall budget per annum.
- 6.2 Whereas there is presently also a capital allocation for carriageway reconstruction, no such funding exists for works on adopted footways.
- 6.3 Adopted footways requiring reconstruction or resurfacing have been identified throughout the city and a prioritised list prepared. This is reviewed annually in preparing the revenue footways programme. The backlog of works identified from the list is presently valued at £3.8 m.

- 6.4 Since footway repairs meet the criteria for Quality of Life funding, allowances of £200,000 in 2004/05 and £300,000 in 2005/06 have been allocated from this funding to assist in addressing the backlog of such work.
- 6.5 The proposed programmes of footway works to be funded from Quality of Life monies in 2004/05 and 2005/06 are indicated in Appendices 1 and 2 respectively. These locations have been abstracted from the top of the comprehensive list based on priority ratings, in parallel with the equivalent proposed programmes to be funded from revenue. Scoring of individual locations has been based on a combination of condition and usage.
- 6.6 As with the revenue footways programme, a number of unforeseen factors can lead to slippage within the proposed repair programme. These include adjacent development construction or demolition, statutory undertakers' major works and cost fluctuations from the initial estimates. To ensure that a satisfactory expenditure profile is maintained, a degree of flexibility is required and it is considered that the City Engineer should therefore have the authority to promote schemes from year 2 to year 1 and from the residual backlog list to year 2 based on priority rating and estimated cost, to deal with any such slippage.
- 6.7 A variety of types of footway treatment are to be utilised in carrying out the footway repairs programme ranging from full reconstruction to a simple overlay. At each footway, consideration will be given to the most appropriate type of treatment with regard to its makeup and condition, to ensure that the maximum number of locations can be repaired from these budgets.
- 6.8 The City Engineer is presently investigating the feasibility of using the Retread recycling process in footway works, as recently introduced in another Scottish authority, and Tayside Contracts are evaluating options for adapting or purchasing plant to suit this activity. It is proposed that a number of locations from within these programmes will be chosen to trial this process. These will be selected following more detailed surveys of site conditions.

### 7 CONSULTATIONS

7.1 The Chief Executive, Depute Chief Executive (Support Services), Depute Chief Executive (Finance), and Chief Executive (Community Planning have been consulted and are in agreement with the contents of this report.
