1.0 PURPOSE OF REPORT

This report reviews the performance of the Social Work Department in relation to its Service Plan 2010-2012 and adds new actions from assessments and reviews carried out in the past year.

2.0 RECOMMENDATIONS

The Social Work and Health Committee is recommended to:

- 2.1 approve the contents of the Social Work Department Service Review and instruct the Director to continue to improve on the level of performance
- 2.2 approve the actions identified in this review that will be included in the Department's Service Plan.

3.0 FINANCIAL IMPLICATIONS

All actions are within the Department's approved budget.

4.0 MAIN TEXT

4.1 Service Plan Context

The Social Work Department Service Plan has a strong focus on making links between the Single Outcome Agreement, The Council Plan and departmental objectives on the planning and delivering of services to the people of Dundee.

There continues to be a strong emphasis on protecting people and we continue to improved scrutiny arrangements, with the regular use of structured case audits and self evaluation as methods of improving standards across all protecting people services.

There is a strong expectation that we will work to deliver personalised outcomes for people and develop an organisational culture which promotes this approach. During the lifetime of this plan and beyond, this combined with, more integrated service delivery, will also reduce management costs and duplication and so improve efficiency. The Department already delivers most services within a context of partnership working, including local authority partners, health services, police and independent providers. There is an expectation that this will continue to improve.

There are significant fiscal and demographic challenges facing the Department in the foreseeable future. The ageing, and in particular, the very old population in the city continues to grow and will produce increasing demand on services and it is essential that we improve the balance of care, by shifting from residential care to delivering services in the community.

There will continue to be challenges from the impact of substance misuse, poverty and health inequalities. This will have a major influence on the demand for all services but in

particular our partners' responsibility to ensure that children are safe, healthy, achieving, nurtured, active, responsible, respected and included and that adults will be protected from harm.

- 4.2 The Department has made the following improvements or sustained a target level in its priority performance indicators -
 - The percentage of looked after children gaining both English and Maths at SCFQ level 3 or above by the end of S4. This is a significant improvement. 69% of care leavers achieved an SCFQ in Maths at level 3 or higher, 44.4% in English and in both.
 - The number of persistent young offenders has decreased from 47 to 33 in the last year
 - Looked After and Accommodated Children in foster care living with Dundee foster carers has increased from 92 in March 2010 to 125 in March 2011
 - Intensive home care as a percentage of all long stay care target of 30% was exceeded (30.25%)
 - The number of respite weeks provided to people aged 18-65 has increased from 703 in 2006 to 3988 in 2010
 - The percentage of Community Service Order clients who started their placement within 7 working days of the order start date improved from 28% in 2009 to 64.6% in March 2011
 - The income generated for Dundee citizens as a result of successful claims for welfare benefits and tax credits has increased from £2.624M in 2007 to £3.410 M by March 2011
- 4.3 The following indicators have shown a decline in trend and will be the subject to detailed performance review in the period ahead -

4.4 Highlights

The Department's key achievements during the year were:

- 4.4.1 Establishing the New Beginning Service from July 2010 to provide services to meet the health and other needs of pregnant women and their unborn babies and babies up to one year old. This includes work with fathers. An external evaluation of the New Beginnings Service by Dundee University commenced in March 2011. The impact of service on reducing health inequalities will be considered as part of this evaluation, and through other self-evaluation processes being developed.
- 4.4.2 Increasing the number and range of accommodation options for young people leaving care. This increase has been achieved with the establishment of a supported lodgings project. There is ongoing work with the largest provider of accommodation which has also increased the type of accommodation options for young people
- 4.4.3 Reviewing and modifying our approach to working with adolescents. The proposals to reconfigure adolescent services were accepted and agreed by Council on 10/02/2011. The

Community Adolescent Team began functioning under its new case holding remit on 2/5/11. A new role for the Choice Project, undertaking diversion from prosecution work for 16/17 year olds, as part of a Whole System approach has been agreed.

- 4.4.4 Establishing a Multi-Agency Screening Hub (formerly MAAT) which became operational from August 2010. This approach hopes to achieve a reduction in unnecessary referrals to the Children's Reporter and that children receive the right help from the most appropriate agency at the right time.
- 4.4.5 Undertaking the production of a draft Dundee Telecare Strategy. The draft Telecare Strategy was presented at the Telecare Project Board meeting on 17th November 2010 and was accepted and approved.
- 4.4.6 Implementing the Enablement Programme for people living in their own homes. The Enablement Service is now taking new referrals from both hospital based service users and those in the community, ensuring equity for service users across the city
- 4.4.7 Following a successful pilot a parenting support assessment is now being used in all teams in Criminal Justice Services the Drug and Alcohol Team and several other services, and informs both the nature of work with offenders and whether any referrals to other services are necessary, including child protection.
- 4.4.8 Reviewing service delivery structures within Criminal Justice Services in order to deliver the new Community Payback Order. This was achieved in time for implementation in early 2011
- 4.4.9 Reviewing the services delivered through Drug Treatment and Testing Orders to ensure appropriate targeting. This paper was considered by the CJS Partnership Management Team in February 2011 and a decision was taken to localise DTTO and progress greater integration with NHS Tayside to ensure CJS substance misuse work is part of local care pathway.
- 4.4.10 Automating the billing process for service user contributions is making more effective use of staff resources. A document consolidating the charging policy in the department has been produced.
- 4.4.11 Accreditation of The Welfare Rights Service under the Scottish National Standards for Information and Advice Providers has been fully implemented. An audit was conducted in July 2010. Welfare Rights Service was successfully accredited in all 32 areas of Welfare Rights and Money Advice at the levels sought. Confirmation obtained in August 2010 and Welfare Rights Service added to the directory of accredited Scottish Advice Agencies. Accreditation awarded until 2014
- 4.4.12 Developing and implementing a Departmental Records, Information and Technology Framework
- 4.4.13 Completing and disseminating to local authorities an Adult Support and Protection Protocol for Tayside
- 4.4.14 Implementing the Child Protection Improvement Plan. Outstanding actions have now been incorporated into CYPPC Action Plan. The Project lead role has now been concluded.

4.4.15 Achieving a reduction of 6688 sick days between the year end 2010 and year end 2011.

4.5 New Actions and Improvements

The Department has taken account of an interim performance inspection report by Social Work and Social Care Improvement Scotland and the indications are that we will have to improve in the following key areas.

- Further develop methods of measuring and improving outcomes for people
- Continue to improve partnership working and commissioning arrangements
- Improving our approaches to risk assessment and risk management
- Improve our methodology for case file auditing and self evaluation

It is likely that a full targeted action plan will be drawn up following their final report later in the summer. At this point additions will be made to the appropriate monitoring database(s).

The Department carries out self-assessment using the Public Sector Improvement Framework and The Social Work Inspection Agency Guide to Self Evaluation. This identifies strengths and areas for improvement. The priority areas for improvement are added as actions for a Public Sector Improvement Framework Improvement Plan which will be reported later in the year. In summary these are:

- ensuring service users and carers are always listened to and sufficiently involved in service development, including the development of the use of outcomes
- moving from the use of performance measures which measure processes and/or service delivery to outcomes which reflect the impact on and for service users
- improving information and communication to service users and carers
- improving staff perceptions, motivation and development and improving the skill level of mangers
- exploring further opportunities for co-location and more integrated services
- establishing a process management system and/or quality management systems in process management
- developing joint training to address the need for a common language for all services to determine 'risk'
- developing our self-evaluation approach with stakeholders
- offering more clarity around how the department recognises and takes account of diversity and different cultural backgrounds when promoting social and cultural activities
- developing robust Training Needs Analysis and Evaluation systems
- providing information on how energy management, material consumption and environmental activities are systematically deployed or if targets are set
- exploring ways of keeping high level risk as a live issues on all senior management meetings.

This assessment and improvement plan will be subject to a separate report later in the year.
