#### 1.0 PURPOSE OF REPORT

1.1 The purpose of this report is to notify Committee of the capital expenditure for I.T. Equipment purchased under the Crown Commercial Service procurement scheme and Public Contracts Scotland framework agreements.

### 2.0 **RECOMMENDATIONS**

- 2.1 The Committee is recommended to:
  - i) Note the I.T. capital purchases amounting to £ 750,509 detailed in appendix 1. This covers the period 1 April 2015 to 30 November 2015.

## 3.0 FINANCIAL IMPLICATIONS

3.1 The Executive Director of Corporate Services has confirmed that equipment with a capital value of £ 750,509 was funded through the current year's allowance of £1.272m for Computer Equipment/IT Infrastructure Requirements in the Corporate Services Department's Capital Plan.

### 4.0 MAIN TEXT

- 4.1 Cost-effective procurement of I.T. infrastructure and software in the Public Sector is largely done through aggregated, pre-tendered framework agreements. These agreements ensure that Public Sector agencies and Local Authorities can take advantage of aggregated demand and pricing. The main procurement routes are the Crown Commercial Service procurement scheme and Public Contracts Scotland framework agreements.
- 4.2 The Executive Director of Corporate Services regularly reports to the Policy and Resources Committee on the I.T. purchases made through the pre-tendered Crown Commercial Service procurement scheme and Public Contracts Scotland framework agreements. All of the expenditure noted in 3.0 above is from approved 2015/16 Capital budgets.
- 4.3 Appendix 1 details the capital purchases made from 1 April 2015 until 30 November 2015.

## 5.0 POLICY IMPLICATIONS
