1 PURPOSE OF REPORT

1.1 This report considers the necessity to introduce a one-way restriction on Kingsway East Service Road.

2 **RECOMMENDATION**

2.1 It is recommended that the Committee approve the preparation of a Traffic Regulation Order to introduce a one-way eastbound restriction on the service road between Pitkerro Road and Westhall Court as indicated on the attached plan.

3 FINANCIAL IMPLICATION

3.1 The total cost of implementing the proposal is estimated at £1,000. Provision will be made from this sum from within the Planning & Transportation Department's 2004/05 revenue budget allocation for the Roads and Transportation Division under Traffic Management Works.

4 LOCAL AGENDA 21 IMPLICATIONS

4.1 Safety is improved by preventing non-residential traffic from using this residential road.

5 EQUAL OPPORTUNITIES IMPLICATIONS

5.1 There are no direct equal opportunities implications arising as a direct result of this report.

6 BACKGROUND

- 6.1 Committee will recall the recent approval of a Report promoting the closure of the Pitkerro Road service road to remove it as an alternative to Pitkerro Road for southbound commuter traffic.
- 6.2 The Kingsway East service road is also used as an alternative to Pitkerro Road via Pitairlie Road re-emerging on Pitkerro Road, assisted by the box junction and achieving a significant advantage in queue position near Kingsway.
- 6.3 The closure of Pitkerro Road service road (6.1 above) is likely to increase commuter activity in this street.
- 6.4 Given the two streets are used in this way it is appropriate that the restrictions are taken forward through formal Traffic Regulation Order consultation and advertising together.
