### 1 PURPOSE OF REPORT

1.1 To seek Chief Officer approval to appoint Safedem Ltd to carry out the demolition of Derwent Arms, Derwent Avenue, Dundee and to appoint Leisure & Parks to carry out post-demolition soft landscaping.

### 2 **RECOMMENDATIONS**

- 2.1 It is recommended that:
  - a the offer of £9,175.00 from Safedem Ltd for the demolition works be accepted; and
  - b an additional allowance of £7,825.00 be authorised to cover, landscaping, disposal, professional fees and contingencies, giving a total expenditure of £17,000.00.

### 3 FINANCIAL IMPLICATIONS

3.1 The Director of Finance advises that these costs will be met from within the Economic Development Revenue Estimates 2000/2001.
