### **1.0 PURPOSE OF REPORT**

1.1 To gain Committee approval for the repointing of a section of Camperdown Country Park perimeter wall from the eastern side of the entrance at Coupar Angus Road and the schedule of rate for the walls.

2.1 That the rate of £39 per linear metre of repair from Tayside Environmental Services Ltd, Dundee be accepted.

### **6.0 MAIN TEXT**

6.1 The condition of the outer boundary wall at Camperdown is in a poor condition and requires upgrading in parts. An allowance of £10,000 has been identified in the Leisure and Arts capital budget for 2004/05 and a tender was invited seeking an all inclusive rate for the repair of a one metre section of wall at the Coupar Angus Road length.

6.2 Tender documentation was sent to four companies and four were returned. The following shows a breakdown of the four offers where a rate for the repair of a linear metre of wall was sought.
