1.0 PURPOSE OF REPORT

1.1 This report details the representations made during the formal publication and consultation exercise on the above proposal and makes recommendations for its resolution.

2.0 **RECOMMENDATIONS**

- 2.1 It is recommended that the Committee:-
 - (i) does not proceed to implement this proposal and that the "status quo" obtains;

 (ii) instructs the Director of Education to undertake a review of the catchment areas for Craigowl and Downfield Primary Schools at an appropriate time after the new schools are occupied

4.0 MAIN TEXT

Background

- 4.1.1 At its meeting of 11 June 2007 the Education Committee approved the report entitled "Dundee Schools PPP Project Catchment Areas for Schools" and agreed (inter alia) to remit the Director of Education to carry out the statutory consultation procedures in terms of the Education (Publication and Consultation etc) (Scotland) Regulations 1981 in respect of a proposal for a revised catchment area for Downfield Primary School at the start of session 2007/08 and to report back to Committee in due course (report no 284-2007 refers).
- 4.1.2 This proposal was advertised in the "Evening Telegraph" on 31 August 2007 and all statutory consultees received a copy of the consultation document on that date.
- 4.1.3 During the period 24 September 27 September, evening public consultation meetings were held at Macalpine and Downfield Primary Schools. Meetings were also held for all staff at each school at the end of the school day. In addition, the Downfield Primary School Parent Council was consulted.
- 4.1.4 A summary of the issues raised at the formal consultation meetings detailed at 4.1.3 above is attached as Appendix 1, and copies of the full notes of these meetings are available in the Members' Lounge along with copies of representations made by letter and email during the consultation period.

- 4.1.5 There was a strong view expressed by Macalpine parents/carers who attended the public meetings that they should receive further communication from the Council inviting them to give an indication of the name of the school to which they would prefer to send their child/children when the new PPP schools are ready for occupation.
- 4.1.6 A letter and questionnaire were sent to all parents/carers of pupils at Macalpine Primary School on 18 October 2007. A copy of each of these documents is provided as Appendix II.
- 4.1.7 The completed questionnaires offered the following information:-

5.0 RESOLUTION OF THE PROPOSAL FOR A REVISED CATCHMENT AREA FOR DOWNFIELD PRIMARY SCHOOL

5.1.1 The proposal to amend the catchment area for Downfield Primary School was generally not supported by the parents/carers. In view of this fact it is recommended that the proposal should not proceed. It is recommended, however, that a review of the catchment areas for Craigowl and Downfield Primary Schools is undertaken once the new schools are occupied and the respective rolls have had an opportunity to settle.

6.1.1 This report has been screened for any policy implications in respect of Sustainability, Strategic Environmental Assessment, Anti-Poverty, Equality Impact Assessment and Risk Management. There are no major issues.
