#### WELCOME AND INTRODUCTION

Councillor Selfridge opened the meeting and welcomed those present.

#### II MINUTE OF MEETING OF 27TH JUNE, 2000

There was submitted and approved minute of meeting of the Joint Panel of 27th June, 2000.

#### III MATTERS ARISING

Further to item III(a) it was noted that the judicial review into the Claypotts planning application had found in favour of Dundee City Council and that a further appeal by the applicants had subsequently been withdrawn.

## IV DUNDEE AND ANGUS STRUCTURE PLAN – FIRST PRELIMINARY DRAFT TEXT

The first draft of the Dundee and Angus Structure Plan was submitted for consideration.

The Panel gave consideration to the document on a section by section basis and a number of areas were identified where amendments were required. In view of the number and nature of the amendments it was agreed that the Directors of Planning be remitted to review the document and that it be given further consideration at an early meeting of the Panel.

It was further agreed that in order to achieve the target date for publishing of the first draft, both Council's would convene special meetings of their Planning Committees.

## V REVIEW OF STRATEGIC SITES

There was submitted and noted a letter from Scottish Enterprise Tayside relative to the above.

#### VI ERROL GRANGE DEVELOPMENT

There was submitted copy letter from the Director of Planning, Perth and Kinross Council, together with a draft reply on behalf of the Panel relative to the above.

The Panel agreed that the draft reply be forwarded to Perth and Kinross Council.

Arising from discussions it was noted that a meeting between Perth and Kinross and Dundee had been arranged for December and it was agreed that this meeting should also include Angus and be re-arranged for January.

# VII CLEAR PROJECT

There was submitted a report dated 18th October, 2000 relative to a request which had been received for the Panel to participate in the CLEAR Project.

The Panel approved the recommendations in the report that:-

- the Panel supports the setting up of a CLEAR Project in relation to the Dundee and Angus Structure Plan; and
- (b) the relevant Council Officers liaise with the CLEAR Programme Manager with a view to ensuring compatibility with ongoing community initiatives.

## VIII LTS UPDATES

It was noted that both Councils' Local Transport Strategies would be submitted to the Scottish Executive in accordance with the identified timetable.

## IX DRAFT PLANS - CHARGING POLICY

It was further agreed that the policies of the two Councils with regard to charging for draft plans be examined with a view to establishing the practice to be applied to the Draft Structure Plan Panel.
